MEMBERSHIP

The Board of Directors has received a lot of questions regarding memberships and fees for 2019 that was discussed at the October meeting. The Board feels we should have further discussion before we go to vote, since any changes will require a complete rewrite of several sections of the Constitution which was just done last year.

There are two aspects of membership that need further discussion.

First, the current definition of Family Membership, refers to a "husband and wife". It has been the "practice" of the Club to "require" a married couple to join as a family membership even if only one of the adults owns or leases a horse. Many believe that married adults should have the option to join as an Individual, since their spouse or children may not be "horse people" and would not use the facility in a family capacity.

The consensus at the last meeting was the definition of "Family" needs to be expanded to recognize all types of unions between two adults, not just "Husband/wife, but to include all unions

irrespective of sex. (Civil unions, domestic partnerships, same sex marriages, etc. legally joined)

Second, there was a proposal made to change the membership to simply single individual memberships (regardless of marital status). Kids under eighteen (18) would be free.

Some additional matters to consider when making changes to our membership status are:

- The Club has permitted the parent or parents of a child who rides to join either as a Single
 Adult or as a Family even when that parent does not ride. Our current definition of member
 does not address this. The proposed membership definitions do not allow for this either. Those parents have been considered regular members with the ability to vote.
- When the Club created the category of Supporting Member some questions came up re:
 whether or not a Member's status must change to Supporting Member when they no longer
 own or lease a horse. This concern was brought forward after the addition of Supporting
 Member and has not been addressed. This needs to be resolved as Supporting Members are
 not eligible to vote.
- If we move to offering only Individual Membership, what would be the status of current spouses and family members who do not ride? (Over the years, the Club has benefitted by the participation of many spouses such as in clean ups, projects, camp maintenance, helping with events, our website, etc.) The ability to vote on club matters is also a consideration in eliminating family membership. Currently, both married persons are eligible to vote.

In closing, RRRC has held itself out as a "Family Oriented" club and if we vote to change our membership definition to "Individual" only, is that move going to impact our overall mission and vision?

One way to resolve all of the above concerns is by:

- 1. Keeping the Family membership, with a change to the definition of "family" as two "joined" adults in the same household (husband/wife, civil union, domestic partners, etc.)
- 2. Change the Definition of "Single" membership (currently defined in the constitution as any single person age eighteen (18) or older with or without children), to "Individual" meaning any individual age eighteen (18) or older.
- 3. Children under age eighteen (18) would be free, no matter which membership level is chosen by the parent.

By changing one word (from Single to Individual) and not mandating the type of membership you must join, appears to work without affecting a complete rewrite of the constitution and would continue RRRC to promote our Club as a Family Oriented organization.

Please consider these so that we can finalize the membership definitions prior to instituting any additional fee changes.



Some Sad News

Robert "Bob" Beaverstock, 92, of Ellington, passed away on Friday, September 28, 2018. Bob was born in Ellington on October 24, 1925 to the late Nelson and Lena (Kellner) Beaverstock. In 1943, he graduated from Rockville High School and started work at Hamilton Standard, where he worked until his retirement. Bob was an avid horseback rider and part timer farmer. He enjoyed traveling and took many wilderness horseback riding trips around the United States, in Ireland and New Zealand. He rode in the Rose Bowl Parade for several years and was the founding member of the Reddington Rock Riding Club and a member of both the CT Trail Riders Association and Granby Horse Council. Bob en-



joyed volunteering for many organizations, and for over 50 years he was the Director and past President of the Four Town Fair. He is survived by his sister-in-law Janice Schaeffer of Ellington and many cousins and friends. He was predeceased by his sister Doris Schaeffer and brother-in-law Charles Schaeffer.
