

There was a short discussion during Old Business regarding fees and membership. The following proposals will be voted on at the Holiday Party.

- 1. Lot fees to increase to \$120 for 2019
- 2. The word "Single" referenced in the constitution & membership materials be changed to "Individual" (as defined in the Constitution)
- 3. Definition of Family in the membership packet be change to as "defined in the Constitution"

It was decided that further discussion is needed surrounding the definition of "Family" and also 2019 dues. So, for now, the dues will be staying at 35 / 70. Should it be decided to increase membership dues for 2019, it will be early spring once the club regroups.

Janet Keown and Sandi Hutchison worked together and were able to complete and submit the Tax Exempt Application to the Town of Stafford to request property tax relief now that we have Non-profit status. It could take months before we hear anything from the town and if relief is granted it will not be in effect until the October 2019 Grand List Valuations.
