

Marines of the League! Wow, it doesn't seem possible that the national convention is over already, it seemed to come and go extremely fast! One of the topics we discussed was USMC Trademarks. USMC allows us as Marines to use the EGA on pretty much anything for personal use, HOWEVER, they have a problem with us making money off them. This comes up periodically when our commandant is schmoozing with command staff, so it's more than an annoyance. It was made clear that we have full control of the EGA when it says "Marine Corps League" or "Marine Corps League Semper Fidelis". So we need to be mindful of the trademarks when we open our ship stores.

Also, we discussed Death Notices (they still seem to be an issue) and Eagle Scout awards paperwork. Death Notice processing is being worked on with the final resolution coming by midwinter. It looks like they are reducing the paperwork and increasing the accuracy. Of the Life member reports, only 40 some percent are being returned, we should lead in this area since ours is a relatively small state. Eagle Scout awards need to be tracked better, we as a League are in the 10-12 percent of Eagle Scouts receiving an award. We also need to do better here...these are well deserving young men (and now ladies) that are earning something big. It's a worthy cause.

Of great interest to our JA is the fact we passed the new Bylaws and Admin Procedures. In fact, I think only a few of the bylaw changes were actually passed, I'm hoping our JA has access to the "Library" for the summary of what passed. These were very contentious this time due to the extent of the changes, however, we did get through it.

I would like to introduce a new Dept. Coin (within the new guidelines) for our Feb 28 staff meeting. I will be meeting with the commandant to discuss a design that will be available for our October Staff meeting. Be ready.

Two weeks ago, as my detachment was in Cripple Creek for the Salute to American Veterans & POW/MIA Motorcycle Rally, it became abundantly clear that summer is coming to an end soon. On Sunday morning of the event, we awoke to snow on the unpaved surfaces and a balmy high of 59 degrees with intermittent showers. As we prepare to step into fall, that means that the children, grand-children, and for some of you, great-grand-children are back in school. Which is also a reminder that Toys for Tots Campaigns in some of our detachments are starting up in about 4 to 5 weeks. If your detachment is in the AOR of a Marine I&I Staff, they are responsible for Toys for Tots in your area. They will be sending their new coordinator off to the national coordinator's training conference in DC, 13-16 Sept. When these "boots" to this new duty return to their commands, they will have just attempted to take a sip of water from a fire hose and may be a bit overwhelmed with the mission before them. They may not admit it right away, but they will need our help. The chore we have is convincing *them* of this fact.

I know we have all had some struggles in the past attempting to work with recruiters, reservists, and the reserve's active duty training staff. You may however, have a great working relationship with the current Marines on staff and they are not only receptive to your support of their mission, but are also willing and eager to engage with your detachment, Young Marine Unit, etc... The days of reserve Marines being activated for a day to do Toys for Tots fund raising events, toy drives, spend a day repairing "gently used toys and bicycles", or color-guard for a holiday parade are long past. The demands that today's recruiters are under as well are just mind boggling. Often times they are working the schools in their AOR during the day, working afterschool events in the evenings and running mini boot camps on the weekends for their pool-ees to prepare them mentally and physically for what lies ahead. Sprinkle in on top of all that the mandatory classroom time recruiters must undergo on the potential dangers both physically and morally that go along with the militant, entitled, sue happy society we live in today and it's no wonder the divorce rate is so high in this MOS.

Here is where our recruiting and retention efforts begin to tie into these active duty and reserve Marines. We are all aware that Active Duty Marines (ADM's) are eligible to be honorary (non-voting) members of our detachments as long as they are on active duty. Reserve Marines (RM's) must pay dues, but are therefore full voting members. I know that in the past we have all run across ADM's that asked, "what's in it for me if I join the League?" Remind them that they get to meet Russ Miller and that should shut them up for about .09 seconds, which gives you some time to think of a good reason. I mentioned in my last article that today's Marine is looking for "mission" and family time.

MISSION: Down in Albuquerque they have had success tying the ADM's from the reserve station into the training for the Young Marines (YM) Unit, and likewise the ADM's have received support from the League and YM side of the house to meet their Toys for Tots mission.

Just because a prior Denver Metro Area Toys for Tots coordinator "wanted to lone

ranger things" and fail miserably, doesn't mean necessarily that the next one will. We need to keep offering as often as it takes to open the door just one time for a positive experience so that the

current coordinator will pass the word in their turn-over-folder to his/her successor how much help and fun it was to work with those crazy Marine Corps Leaguers.

FAMILY TIME: During the recent 1<sup>st</sup> Marine Division Association Reunion here in Colorado Springs, I was able to talk to a couple of Marines from back east that have begun to build an incredible working relationship with their area recruiting staff by going to area hotels and restaurants and asking for free, if not at a greatly reduced price, one-two night stays and first class meals for a recruiter and their spouse. They worked it out with the SNCOIC to determine a recruiter of the year, which later became quarterly and now monthly, that would be awarded the hotel stay and meal. A family from the detachment could offer to watch their children for the night while they get some alone time and recharge.

Those of us that pulled recruiting duty well remember the stress it played on our relationships and the number of Marine's marriages that failed during that time. This has been a successful tool for them back in Pennsylvania and New Jersey at their detachments both in recruiting these ADM's to the League, and those ADM's are much more willing to support the League's missions because they have seen tangibly that they are being supported as well. The last thing any of us want when we meet an active duty Marine on the street is, to upon us saying we are in the League, for them to roll their eyes and walk away shaking their head. Happened to me twice over the years. We instead want to hear from a detachment across the country, the story like we had at our July monthly meeting in Colorado Springs, when, an ADM Gunny on terminal leave stood up and announced that the positive experience he had with the Marine Corps League when he was on I&I duty as the Toys for Tots Coordinator was what drove him to search out our website and show up to join our detachment so he could pay-it-forward.
