- 6) Upon request from the Buyer(s), the Seller(s) will at his/her/their discretion apply the deposit toward the purchase price of a puppy in the next available litter. The request must be made in writing before the pickup date stated in this agreement. The request can be emailed, texted or mailed to the Seller(s).
- 7) If the Buyer(s) change(s) his/her/their mind, the Buyer(s) must notify the Seller(s) in writing with 24 hours of signing this agreement. Failure to do so will result in a forfeiture of the deposit. If the request is received timely, the Seller(s) will apply the deposit toward the purchase price of a puppy in the next available litter.
- 8) If the Buyer(s) or Seller(s) commence any legal action as a result of this contract, Buyer(s) agree(s) that the place of venue for any such legal actions shall be the state of Tennessee, Hardeman County. Any legal fees incurred in upholding this Deposit Agreement will be paid by the Buyer(s).
