

# Puppy Purchase Agreement

This Purchase Agreement is between Buyer(s),

and Seller(s), Tyrone and/or Sharon McNeal. This agreement is effective as of the date signed and is binding upon all parties. Buyer(s) and Seller(s) agree to the below described puppy and all of the terms listed herein.

- 1) The Seller(s) guarantee(s) this puppy to be of good health at the time of sale. It is the Buyer's responsibility to have the puppy examined by a licensed Veterinarian with 72 hours (3 business days) after adoption. This is your health guarantee period.
- 2) The Buyer(s) understand(s) that at no time for any reason will there be a monetary refund of the purchase price. All deposits are nonrefundable.
- 3) If the puppy is found to be medically deficient with an untreatable life threatening problem (must be documented by a licensed Veterinarian), the problem must be reported within 1 hour to the Seller(s). All veterinary fees/costs are the responsibility of the Buyer(s). Buyer(s) must provide Seller(s) with a copy of the Veterinarian Statement. The Seller(s) agree(s) to replace the puppy with another puppy from the same litter if available or with a puppy from the next available litter.

- 4) All sales are final after the health guarantee period (72 hours) has expired. No returns, refunds or exchanges will be allowed after the health guarantee period has expired.
- 5) It is the Buyer's responsibility to provide immediate veterinary care to any puppy showing signs of illness or distress. Failure to do so will render any warranty/guarantee null and void. All veterinary fees/costs are the responsibility of the Buyer(s).
- 6) The puppy is guaranteed against congenital defects which would adversely affect the health, value or life of the puppy up to the age of 1 year. An in-descended testicle, hernia or ears that do not stand up are not included in this guarantee. Any condition that is minor, correctable or which will go away as the puppy gets older are not covered by the 1 year guarantee.
- 7) For any hip related issues, the puppy has to be at least 6 months of age before x-rays will be reviewed in consideration of a replacement puppy.
- 8) If there is a serious genetic defect found within the first year, it must be documented by a licensed Veterinarian. The puppy must be returned within 3 days of the signed Veterinarian documentation. The Buyer(s) must provide Seller(s) with a copy of the Veterinarian Statement. The Buyer(s) is(are) responsible for all veterinary costs. This guarantee is void if the puppy/dog develops any defect(s) due to neglect, puppy/dog food, puppy/dog supplements, environmental condition(s) or any circumstance(s) beyond the sellers control.
- 9) The Seller(s) agree(s) to replace the puppy with a puppy from the next available litter. The Buyer(s) understand(s) that the replacement puppy may not be from the same Sire or Dam. The Buyer(s) understand(s) that at no time for any reason will there be a monetary refund of the purchase price.
- 10) The Buyer(s) understand(s) that this warranty does not include any contagious diseases, bacteria, viruses, parasites, protozoan or fungus.
- 11) The Buyer(s) understand(s) that this warranty does not include the size, weight, eye color, coat color or length of the puppy.
- 12) No other warranties or guarantees, expressed or implied, are made under this contract except as stated above.
- 13) If the buyer(s) can no longer care for the puppy/dog, the seller(s) is(are) to be notified. The buyer(s) agrees to forfeit (return) the puppy/dog to the seller(s). All costs to return the puppy/dog is the responsibility of the buyer(s). There will be no refund of the purchase price. The buyer(s) understand

that a \$5,000 fine will be assessed against the buyer(s) and will be payable to the seller(s) if the buyer(s) turns the puppy/dog over to a shelter or sells the puppy/dog without the knowledge and permission of the seller(s). This paragraph only applies to the puppy/dog who is less than 3 years of age and has been AKC registered.

14) If the Buyer(s) or Seller(s) commence(s) any legal action because of this contract, The Buyer(s) agree(s) that the place of venue for any such legal actions shall be the state of Tennessee, Hardeman County. Any legal fees incurred in upholding this Purchase Agreement will be paid by the Buyer(s). This Purchase Agreement is legally binding to all parties involved and is not transferrable. If the Buyer(s) sell(s) or gives the puppy to a 3<sup>rd</sup> party, this Purchase Agreement immediately becomes null and void. The Buyer(s) agree to notify the Seller(s) within 24 hours if the puppy is sold or given to a 3<sup>rd</sup> party.

## Important Information

Vaccinations and de-wormings are very important for your puppy. A puppy's immunity must be built up by a series of vaccines/vaccinations.

It is in the best interest of the puppy if you keep it away from other animals outside of your home and from travelling until the puppy has had a chance for its vaccines to become effective. This is usually around 4 months of age.

DO NOT take your new puppy into any pet store until the puppy has had a chance for its vaccines to become effective. Pet stores are prime breeding grounds for a contagious disease, virus, parasite, protozoan and fungus.

Following the steps above will decrease the chance of your puppy getting sick from a contagious disease, virus, parasite, protozoan and fungus until its vaccines have had time to become effective.

Please put your puppy on a heartworm preventative and a flea & tick medicine. Your veterinarian can tell you when to start these medications and can suggest which medications to use. It is extremely important that your canine remain on these medications for life.

### **Suggestions:**

**Food** - The puppy is on a current diet of Eukanuba Large Breed Puppy Food. We recommend feeding Eukanuba Large Breed Puppy Food for the first 2 years before switching to an adult dog food.

**Calcium Supplement** - We like to put our puppies on Grow Sure 100 by Lambert Kay. It is a calcium phosphorus vitamin supplement to promote optimal bone development. This is totally optional.
