



CONSIGNMENT AGREEMENT

This Consignment Agreement is made and entered into this day by and between A Bit Less, LLC (Consignee) and the undersigned person (Consignor); and is subject to the terms and conditions set forth below:

A Bit Less will accept saddles, tack, equestrian apparel, and other equine related products and supplies. All items must be clean, in good condition, and in good repair. Consignments will be accepted by walk-ins during business hours or by appointment. A Bit Less reserves the right to hold and review any consigned item for five (5) business days from the date on the signed consignment agreement to determine the items acceptability and pricing. Pricing is based on the condition, quality, age, and marketability of the item.

A Bit Less retains the right to refuse or return any item(s) to the Consignor. If an item is refused, A Bit Less will notify the consignor and the consignor has five (5) business days to retrieve the item. If not retrieved within the specified timeframe, the item(s) will be considered abandoned and will be donated to a local charity or otherwise discarded. A Bit Less reserves the right, with consignor's permission, to repair or clean item(s) at Consignor's expense, if such repairs or cleaning will improve the marketability of the item. The cost of said repairs or cleaning will be deducted from the owner's payment. Repairs and cleaning are strictly limited to aesthetic improvements; A Bit Less will not accept items whose safety or functioning is compromised.

A Bit Less will retain a 50% commission on general merchandise and a 30% commission on all saddles. A Bit Less reserves the right to accept reasonable offers on items and to hold periodic sales. Items may be displayed and marketed on our website (www.abitlestack.com), social media, or other means at the discretion of A Bit Less.

Consignment Period for saddles and general merchandise shall be 180 days (90 days for apparel) from the date the item is accepted for consignment. After 90 days (45 days for apparel), the price of the item may be reduced by up to 50% at the discretion of A Bit Less. If a consignor chooses to remove any items from consignment before the consignment period has passed, he or she will be charged the commission based on the price tag on the item. Payment will be required prior to item(s) being returned to the Consignor.

It is the responsibility of the Consignor to contact A Bit Less at the end of the initial contract period to collect payment for items sold, request an additional consignment period, reclaim the items, or request the items be donated to a local charity. If the contract is not extended and the item is not picked up within 30 days after the consignment period ends, the item will be considered abandoned and will become the property of A Bit Less.

Payment of any funds generated through the sales of consigned items will be made only during the consignment period and at the request of the consignor. A Bit Less will not send out notification of consignor's balance or notify consignor when an item sells. It is the consignor's responsibility to inquire about their balance in person, by telephone at 541- 323-3262, or by emailing: info@abitlessequine.com. Payments will be available no later than 5 calendar days following the request at A Bit Less. A Bit Less will mail checks upon request. A \$1.00 service fee will be charged for mailed checks and it will be deducted from the total of funds issued. If requested payments are left unclaimed after 30 days or consignor does not request funds generated through sales within 30 days after the consignment period ends, payments will become null and void and consignor forfeits his/her right to funds. Consignors may choose to use their balance in full as store credit and receive a store discount of 5% up to the value of their current balance.

It is the Consignor's responsibility to ensure A Bit Less has current and accurate contact information to include full name, mailing address, email address, and telephone number.

Consignor represents and warrants that he/she is at least 18 years of age, is the owner of all goods consigned to A Bit Less, LLC and he/she has the legal standing and capacity to enter into this Consignment Agreement; and that the goods are saleable and/or free & clear of liens, loans, legal proceedings or other ownership encumbrances. Consignor shall indemnify, release, defend, and hold harmless forever A Bit Less, its partners, employees, successors, vendors, and customers and assigns from any and all claims and liabilities, of whatsoever kind (including but not limited to attorney's fees), arising from or connected to the consigned goods. A Bit Less shall use all conventional safeguards in the handling and displaying of consigned goods but has no legal responsibility for items left on consignment.

All terms and agreements are binding. All sales are the sole responsibility of A Bit Less, LLC.
