**9. Fire Chief's Report:**

- Discussed last month's calls.
- Smith Valley Volunteer Fire Steak BBQ event was a success.
- The District is now funding the Volunteer incentive since the SAFER grant has ended.
- The Volunteer's will now need a purchase order when using their uniform allowance.
- The Quad Counties for Fire (Carson City, Douglas, Lyon and Storey) have approved common radio ID for numbering and unit designation. It should go into effect in the next three months. We will have to change medic to rescue and rescue to squad.

- Lyon County may be interested in selling the Chief's old car he used to the District. They have not decided on a price yet.
- We have been having training on the Rhino and the new engine.
- No fire restrictions are in effect yet.

**10. Board Member Comments:**

- Director Spencer presented William W. Park with a Certificate of Appreciation for all of his endless and hard work on the apparatus.

**11. Discussion and possible action on the status and repair of District equipment:**

- Chief Loveberg discussed the new battery charger on B40 and the new engine. The Volunteers have purchased some new equipment for apparatus such as a positive pressure ventilation fan and new hose for the new engine. Utility 41 has a new battery. Medic 40 lost engine power on a call but it has been repaired. All other equipment in good repair.

**a. Discussion and possible action regarding a work contract for landscape maintenance at the fire stations:**

- Tom Spencer has taken over getting bids for landscaping maintenance. He asked the Board if he could have until next month to review the bids.

**b. Discussion and possible action regarding annual heating and air conditioning maintenance estimates for the fire stations:**

- Tom Spencer contacted six companies and three responded. See enclosed quotes to service the heating and air conditioning equipment annually. Discussion on the different companies and their quotes. Director Spencer motioned to accept the bid and services as presented to us from Hardesty's General Repair to provide services and to replace the thermostats if necessary. President Hunewill seconds and all were in favor. The motion passed.

**14. Discussion and possible action regarding the purchase of a new water tender:**

- The chassis has been delivered. 4 Guys will provide a Certificate of Origin after we pay for the chassis which will save the District a couple of thousand dollars. They are installing the pump now. Chief Loveberg recommended we send someone to their facility to inspect the tender.

- Chief Loveberg has been talking to Highway Products and will be moving forward to accept their bid.

- Chief Loveberg has completed the final version. See enclosed incentive for 2011/2012. Director Spencer motioned to approve the incentive program for 2011/2012 as presented in final form. President Hunewill seconds and all were in favor. The motion passed.
