PLEASE INITIAL THAT YOU HAVE READ, UNDERSTAND AND AGREE TO THE FOLLOWIG:

**AGE RESTRICTIONS**

\_\_\_\_\_ **Participants must be over the age of 5.**

\_\_\_\_\_ Minors under the age of 18 must be accompanied by a parent or legal guardian.

\_\_\_\_\_ Minors must be at least 12 years of age to operate their own boat without an adult.

\_\_\_\_\_ Minors under the age of 12 must ride in a boat with an adult.

\_\_\_\_\_ Participants 12 years and older will be priced as an adult.

**RESPONSIBILITY OF PARTICIPANTS**

\_\_\_\_\_ Participants must provide their own transportation to and from scheduled tour site. Participants will be responsible for any and all parking or park entry fees associated with parking or entry to a designated tour site.

\_\_\_\_\_ Participants must review, agree to and sign a liability waver provided by Clearly Tahoe LLC in order to partake in scheduled activity.

\_\_\_\_\_ Participants will be required to listen to a brief safety, rules and regulations lecture before attending a tour.

\_\_\_\_\_ Participants will be required to wear a US Coast Guard approved life preserver provided by Clearly Tahoe LLC.

**ABILITY**

\_\_\_\_\_ Passengers must be physically and mentally capable of participating in the described activity. Guests must note any knowledge of medical history that might affect his, her or their family's ability to participate in described activity.

\_\_\_\_\_ Participants will be required to enter up to 3 ft. of water prior to boarding the boats. They must be

capable of entering and exiting the boat without assistance.

\_\_\_\_\_ **Total combined boat load must not exceed a weight of 375lbs.**

**RULES/REGULATIONS**

\_\_\_\_\_ No footwear will be permitted in boats. All foot or ankle jewelry must be removed or covered.

\_\_\_\_\_ No alcohol, drugs or controlled substances of any kind will per permitted in on the tour. No smoking will be permitted during tour.

\_\_\_\_\_ No weapons of any kind will be allowed in the kayaks.

\_\_\_\_\_ No pets of any kind will be permitted in Clear Kayaks. If service animal is necessary, arrangements can be made. These arrangements must be made at time of booking.

\_\_\_\_\_ Personal items should be kept in dry bag or waterproof container. Clearly Tahoe LLC prohibits any kind of container or bag that might scratch or damage the kayaks in any way.
