Location: Army Airfield, Coffeyville Industrial Park, Coffeyville, KS 67337

Date/Time: Saturday, April 27th, 2019. Vendors should be on site by 9:00am and ready to serve customers by 11:00am.

About: This event in its birth brought 2,000+ people out to see street racing in our hometown of Coffeyville, KS. Three men, and their wives, took it on themselves to create this event to benefit our local businesses and economy. Coffeyville Street Drags could not have been possible without our great sponsors, volunteers, and community.

Attendance: Our past events brought in around 2,000 spectators and 100 participants. We expect this event to continue growing by leaps and bounds.

Fees: \$150. Application must be received by no later than Friday, April 10, 2019. Please submit either via email at coffeyvillestreetdrags@gmail.com or through mail to PO Box 423, Coffeyville, KS, 67337. We will contact accepted applicants by April 15th, 2019. Fees will be due by April. 20th, 2019. All fees and deposits are nonrefundable after April 20th, 2019. In the event of a rain out, the event will be rescheduled and vendors notified of alternate date as soon as possible.

Food Truck Application Acceptance Policy: Upon receipt of the applications, we will review all menus and item descriptions to ensure that we are providing a variety of options for event attendees. While we are unable to guarantee there will not be competing vendors, we will take this into consideration as we plan our event. The Coffeyville Street Drags reserves the right to turn down applications based on the number of applications received and overall variety of applications. We will contact accepted food trucks by April 15th, 2019.

Proceeds: Food trucks keep 100% of their proceeds from sales on the day of the event.

All operational forms required to comply with local and state laws are vendor responsibility.

Set-up, Hours, Teardown: Food Vendors may begin to arrive as early as 9:00 am on Saturday, April 27th, 2019. All set-up must be completed by no later than 10:00 am. The event begins at 11:00 am, but attendees will begin arriving at 10:00. All food trucks are required to remain open until 10:00 pm on event day. There will be NO teardown prior to 10:00 pm.

Staff: Each food truck will receive 2 passes to the event for workers. If you have a product that requires more, please contact us.

On-site Resources: All food trucks and vendors must be able to operate independently of any provided resources including water, electrical, refrigeration, and any materials. Vendors are responsible for all set-up and clean-up of their booth space and the immediate area surrounding such space.
