Proposed 2019 Budget and Reserve Study: Community Manager Dawn Ubando presented the 2019 Operating Budget and Reserve Study for the Crowne at Wailuna to the Board of Directors for their review and approval. After review, and being that the Board of Directors reached a consensus on all line items, President Antinoro moved to approve the 2019 operating Budget. The motion was seconded by VP Richards and passed unanimously.
