**“YOUR ACCOMMODATIONS UNDER THE AMERICANS WITH DISABILITIES ACT -- STRATEGIES TO GET THEM”** – Nelson Thomas, Esq.

Suppose you're in a public place with no provision for hearing-disabled people, and the management knows nothing about making the place accessible to you, or refuses.

Attorney Nelson Thomas, Esq., previously a member of our Professional Advisory Committee, suggests specific steps and strategies for those with hearing loss to receive the accommodations they are legally entitled to from places of public accommodation. A few of many examples are hospitals, doctors' offices, theaters, etc.

The Americans with Disabilities Act (ADA), signed into law in 1990, was created to make American society more accessible to people with disabilities. The ADA Amendments Act passed in 2008, broadens the definition of disability.

We people with hearing loss are considered disabled and are entitled to “accommodations” in many circumstances.

**INDIVIDUALS WITH HEARING LOSS AND THE MONROE COUNTY ADULT HEALTH SURVEY: YOUR OPINION IS NEEDED** – Byron S. Kennedy, M.D., PhD, MPH

The Monroe County Department of Health seeks your input. The Department has been attempting to include hearing-disabled individuals in its Adult Health Survey. Deputy Director Dr. Byron S. Kennedy will present data on local health indicators including those from the 2012 Adult Health Survey for Monroe County. People with hearing loss are considered a “**vulnerable subgroup**.”

Dr. Kennedy will explain this term and will comment further on public health statistics for people with hearing loss and their disparities from other respondents to the survey. He is particularly interested in audience input to consider potential “next steps” in future surveys including hearing-disabled community members.

## ALERT DEAF POPULATION, TOO

Rochester has the largest deaf population, per capita, in the US, yet our local broadcast media continue to ignore us. What happened during Superstorm Sandy is a perfect example. While a potential hurricane was bearing down on Rochester, county officials sent press releases to the media to warn citizens of the approaching danger. These critical, life-saving announcements were reported on our local news stations as “emergency reports” and “breaking news.” **Because these reports were live, there was no captioning...meaning thousands of people were not considered important enough to be informed.**

Our local TV stations use a method of captioning newscasts that makes it impossible for deaf (or, people with hearing loss) to understand what's being said. I challenge any “hearing person” to watch a local TV newscast with the sound off, and the captioning on. You will have no idea what they're talking about. Sadly, the FCC does **not** require Rochester stations to provide live captioning, but when there is an emergency, they're required to do so. There are no exceptions.

The primary method of communication for the deaf is a sign language interpreter. Why not add those bubble interpreters during emergency announcements? Monroe County is required to prepare for disasters. This includes having funds available, in advance, for sign language interpreters and live captioning on TV. From what we saw with Sandy, there is no preparation at all! Does a deaf (or hard of hearing) person have to die from their negligence before action is taken?

## NEED A CAPTIONING SERVICE & CAN'T FIND ONE?

**CaptionMatch** (<http://captionmatch.com>), is a new service for matching captioning providers with those who need a captioning service. CaptionMatch began its service at the end of 2012, so at this point it's not a fully tested business. CaptionMatch has an association with The **Collaborative for Communication Access via Captioning** (CCAC - <http://cccaptioning.org>), which is a volunteer captioning advocacy group.

Individuals or companies, which *provide* captioning services, register with CaptionMatch and pay a small fee. Those interested in *obtaining* captioning services also register with CaptionMatch however there is no fee for the individual or group requesting the match for service.

CaptionMatch makes its profit from the registration fee paid by captioning service providers and a fee/percentage of the money received by the provider after they've provided captioning service for the customer. The "matches" made by CaptionMatch are based on the needs of the client, and information the captioning service provided to CaptionMatch when registering. CaptionMatch is out of the picture once the provider and client are successfully matched.

It's important to note that CaptionMatch provides only a subset of caption providers; that is, those that register with them. Neither CaptionMatch nor the CCAC, insure satisfaction between provider and customer. Hearing loss does not just affect older Veterans. Many of our young Veterans returning from Operation Iraqi Freedom and Operation Enduring Freedom also suffer from hearing loss. One recent VA report estimates that the number may be as high as 59,000.

Given the higher incidence of hearing loss among Veterans of all ages, the VA has an extensive network of services and benefits for Veterans to cope with hearing loss. ## SONY GLASSES – FOR CAPTIONS AT REGAL THEATRES

I was issued the glasses and given a short demonstration on how they work. I also was given another small electronic device that links a wire to the glasses which provides the captioning. I had to sign my name, address, and phone number after receiving the glasses.

The small electronic device needs to be facing the screen, either in your shirt pocket, hand held, resting on your chest; or they have a neck attachment (which I used) to hold the device just below your neck comfortably. (If you go, request this.)

The unit also has a head set plug. But it does not work with a neck loop, or a silhouette, which I tried. It only works with their ear plug or head set. I gather the impedance is geared only for their headsets.

I could turn my head, move my body, look around, and never lost captioning. I could move the captioning on the screen up, down, sideways, by moving my head as the device was facing the screen. I preferred looking straight ahead and keeping the captions below the movie picture. The captioning in all captioned movies with the SONY glasses is in the color green. So if there were certain colors in the movie background that were green, you will lose some of the captions. So I kept the captioning below the screen, in a complete black area, and the green stood out perfectly.

You can also make the captions brighter and/or larger, with the select (SEL) button on the small electronic device that is wired to the glasses. On the device it has a (-) on the left, to lower the volume and a (+) on the right, to raise the volume. The SEL button is in the middle, and by pressing it, you can choose how large and wide you want your captions, and how bright. I kept my

brightness on level 3 out of 5. I kept captioning size at normal. (Contact: [ajs36csf@rochester.rr.com](mailto:ajs36csf@rochester.rr.com).)
