Strategic Planning Last month Suzanne focused on the scope of our HLAA-Rochester Chapter activities and the Strategic Planning

On a project I managed years ago I learned a process used by Kodak. First, *Vision* the future we hope to attain. Through our Strategic Planning we hope to determine our *Vision* for the future and develop the *Thrusts* necessary to get there.

#### **RIT NEWS: NEW APP ENHANCES MUSEUM ACCESSIBILITY FOR VISITORS**

A new app developed by researchers at NTID is providing a <u>self-guided tour platform</u> designed to enhance accessibility for all visitors in museums. Museum visitors can use the app, MUSEAI, by inputting a number that is placed next to the artwork, which will provide them with the information about a specific artwork, including descriptions, historical facts, media (video/audio) with captions, audio descriptions and more. The app is being used for the <u>first time nationally at</u> <u>Rochester's Memorial Art Gallery</u> in a current exhibit, "De'VIA: The Manifesto Comes of Age," which runs through February 16, 2020.

HOPE Session 12/3/2019 By Joe Kozelsky, abd, MS, CCC-A (retired)

There were 5 new people and 12 current HLAA members. One of the new people was <u>experiencing</u> <u>issues with his hearing aid and was in the last day of</u> <u>his 45-day trial</u>, and he wondered how to proceed. He was informed that he might expect that he could ask for adjustments and an extension of the trial period to see how it works out.

Another topic that came up had to do with annoyance or discomfort from <u>loud</u>, <u>sharp sounds</u> including flush toilets and surprisingly, even newspapers. The point was made that nowadays, users should not be bothered by such sounds. Yet another complaint had to do with <u>discomfort from</u> <u>the hearing aid or the ear piece</u>. This is a difficulty that users should never have to put up with. If it happens to you, contact your provider. There was a comment about difficulty with <u>understanding fast</u> <u>speech</u> – it was recommended that if you want other people to talk slower, then you have to talk slower first, so as to set the pace.

Finally, there was a fair amount of discussion about <u>hearing on the phone</u> which concluded with a recommendation to visit the Device Demo Center.

I will be away for the next three sessions, back again in April. **Dr. Jim Feuerstein** will be facilitating the next three meetings. Happy Holidays to all.

The Roger pen and MyLink receiver work with any brand of hearing aid equipped with a t-coil, so it is not limited to Phonak owners.

#### HOUSE PASSES BILL FOR MEDICARE COVERAGE OF HEARING AIDS 12-10-19

In an historic achievement, the House of Representatives has voted to expand Medicare to cover hearing aids and related hearing health care services. By a vote of 230-192, the House approved HR 3 bill.

While the House action is a significant step forward, <u>much work remains to be done before Medicare</u> <u>coverage of hearing aids becomes a reality</u>. HR 3 now goes to the Senate where there is opposition to negotiating drug prices. Many Senators, as well as the Trump Administration, are exploring other ways to lower the cost of prescription drugs. Whether these alternatives will also include hearing aid coverage under Medicare remains to be seen.

While prospects for final action on HR 3 remain uncertain, the House vote is a milestone achievement on an issue that has been an HLAA top priority for many years. HLAA was among the earliest and most vocal supporters of Medicare coverage for hearing aids, and worked closely with key members of Congress this year to include the language in the prescription drug negotiation bill. As the issue moves forward, HLAA staff will continue working with Congress, Medicare experts, and other hearing health care organizations.

When Congress created Medicare in 1965, it expressly excluded hearing aids. More than 50 years later, HLAA is setting the stage to correct that oversight. (from HLAA national email)
