INSTALLMENT PLANS AVAILABLE FOR ON CAMPUS CLASSES:

- ❖ **Annual Installment Plan** – To be paid in full by June 1st. This plan is payable in check, cash or credit card.

- ❖ **Twelve Month Installment Plan** – To be paid in 12 equal installments from June through May. Colorado Springs Christian Schools requires that all monthly plans be managed through the FACTS Tuition Management Program. The draw will be made on the 5th or the 20th of every month. The annual enrollment fee is **\$45 per family**. There is a \$30 late fee if funds are not available when the attempt is made for withdrawal. A second attempt is made 15 days after the first attempt. FACTS Tuition Management System reserves the right to charge additional fees for any payment returned. - ❖ **Ten Month Installment Plan** – To be paid in 10 equal installments from June through January, March and April. Colorado Springs Christian Schools requires that all monthly plans be managed through the FACTS Tuition Management Program. The draw will be made on the 5th or the 20th of every month. The annual enrollment fee is **\$45 per family**. There is a \$30 late fee if funds are not available when the attempt is made for withdrawal. A second attempt is made 15 days after the first attempt. FACTS Tuition Management System reserves the right to charge additional fees for any payment returned. - ❖ **School Year Installment Plan** - To be paid in 10 equal installments from August to May. Colorado Springs Christian Schools requires that all monthly plans be managed through the FACTS Tuition Management Program. The draw will be made on the 5th or the 20th of every month. The annual enrollment fee is \$45 per family. There is a \$30 late fee if funds are not available when the attempt is made for withdrawal. A second attempt is made 15 days after the first attempt. - ❖ **Semi-annual Installment Plan** - To be paid in 2 installments. 1st installment to be paid by June 1st and balance due on December 1st. This plan is payable in check, cash or credit card.
- ❖ **Nine Month Installment Plan** - To be paid in 9 equal installments from June through February. Colorado Springs Christian Schools requires that all monthly plans be managed through the FACTS Tuition Management Program. The draw will be made on the 5th or the 20th of every month. The annual enrollment fee is **\$45 per family**. There is a \$30 late fee if funds are not available when the attempt is made for withdrawal. A second attempt is made 15 days after the first attempt was returned. FACTS Tuition Management System reserves the right to charge additional fees for any payment returned. - ❖ **Eight Month Installment Plan** - To be paid in 8 equal installments from July through February. Colorado Springs Christian Schools requires that all monthly plans be managed through the FACTS Tuition Management Program. The draw will be made on the 5th or the 20th of every month. The annual enrollment fee is **\$45 per family**. There is a \$30 late fee if funds are not available when the attempt is made for withdrawal. A second attempt is made 15 days after the first attempt. FACTS Tuition Management System reserves the right to charge additional fees for any payment returned. - ❖ **Modified Monthly Installment Plan** – ***This plan is only available for families who apply or re-enroll after June 20th.*** Tuition must be **paid in full by the end of February**. TUITION CONTRACT

Upon acceptance of your student, a Tuition Contract will be generated and sent to you electronically through DocuSign. Please complete the Tuition Contract within ten (10) days of the date the contract was prepared or prior to student starting school, whichever comes first. Notwithstanding completion of the application or the Tuition Contract, CSCS reserves the right to deny a student admission for financial, behavioral, or academic probation reasons.

FINANCE CHARGE/LATE PAYMENT CHARGE/MISCELLANEOUS CHARGES

Because CSCS has a commitment to pay its bills and financial obligations on time, we encourage each family to keep their account current and up to date. Late payments and outstanding balances will be handled in the following manner:

- A **finance charge of up to 3%** may be assessed at month end to all accounts that have a balance 60 days or greater.
- A late payment charge of \$30 will be assessed if payment for tuition and/or fees is not received within five (5) days of the date the payment is due.
- A \$30 charge will be assessed for any checks being returned by your financial institution.

Upon receipt of your Tuition Contract and/or acceptance of your student, CSCS recognizes your commitment to the school year. Therefore, when a student is **withdrawn after August 1**, CSCS will release Parent(s) from the obligation to pay a full year's tuition only in exchange for a **payment of \$250**, together with payment of any non-refundable tuition CSCS has paid to Sevenstar and non-refundable fees (including, but not limited to, the Application Fee, Acceptance Fee, Re-enrollment Fee, and Student Activity Fee). When a student is **withdrawn after the start of school**, CSCS will release Parent(s) from the obligation to pay a full year's tuition only in exchange for a **payment of \$500 or the pro-rated tuition amount, whichever is GREATER**, together with payment of any non-refundable tuition CSCS has paid to Sevenstar and non-refundable fees (including, but not limited to, the Application Fee, Acceptance Fee, Re-enrollment Fee, and Student Activity Fee). Any payments received by CSCS for withdrawal of student shall be deemed liquidated damages and not a penalty.

PLEASE NOTE: CSCS pays Sevenstar's full tuition for Student's online course(s) upon registration with Sevenstar, which is prior to the beginning of the course(s). Once registration with Sevenstar has been completed, Sevenstar will only refund CSCS a portion the tuition for the course(s) as per the course information document. Therefore, Parent(s) are responsible to maintain their payment plan until they have paid to CSCS the portion of tuition for which CSCS was not refunded. This amount of tuition is in addition to the liquidated damages as stated in the above paragraph, regardless of when Student withdraws from Sevenstar class(es).

PLEASE NOTE: Families must have 1/3 of the cost of the Sevenstar courses paid for before CSCS will order the courses.
