Revised July 31, 2020 (As our pandemic situation and guidelines from health officials are continually changing, this plan is subject to revisions to allow the Long County School System to implement the most up-to-date recommended procedures for protecting students, staff, and families.)

Co-teachers, ESOL teachers, migrant specialists, paraprofessionals, custodians, administrators, and all other employees who must serve multiple classes are required to wear masks throughout the day and wash hands in between each transition.
