CANCEL MY MORTGAGE CONTRACT?

THAT'S RIGHT, YOU CAN RESCIND (CANCEL) YOUR MORTGAGE CONTRACT AFTER NEW COURT RULINGS: Assignee Liability:

Assignee liability is an important issue in the rescission process. The general rule for assignee liability, set forth in section 131 of TILA, 15 U.S.C. § 1641, is that the assignee of a credit transaction covered by TILA and Regulation Z is only liable for violations that are apparent on the face of the disclosure statement.

OKAY, NOW LET US EXPLAIN WHAT THIS MEANS:

First, the Assignee is the mortgage company, not the borrowers. The Regulation Z law was written to make the mortgage company follow proper procedures in the mortgage loan process.

However, section 131 specifically exempts rescission from this rule so a borrower could compel the assignee of a loan with violations triggering the right of rescission to rescind the loan, even though the violations are not apparent on the face of the disclosure statement. Thus, banks must be careful when purchasing loans subject to rescission. When you're awarded a rescission, the bank has to return all finance charges and fees to the customer and the bank is also liable for statutory damages, court costs, and attorney's fees incurred when you file the Right of Rescission. In addition, rescission applies to assignees of the loan, meaning every mortgage company that you original lender assigned your mortgage to. You see, if your original lender assigns your loan

to a bank and your loan is a covered loan, the new assignee could be forced to rescind the loan if the disclosures have violations triggering your Right of Rescission

So, the Federal Law, the Truth In Lending Act (also referred to as Regulation Z or Reg Z or TILA), clearly outlines the responsibilities of the Assignee (a mortgage company).

It's important to note that a rescission action cannot be barred by prior or subsequent TILA litigation, if the prior litigation DID NOT involve rescission. This means that if you have filed a Right of Rescission in the past and were not awarded the rescission, you can file again now with this new look at the Regulation Z. This is due to numerous court discussion on this subject over the past few years, so there is hope for your process now.

The statute and Regulation Z states that if a creditor disputes the consumer's right to rescind, that creditor must file a declaratory judgment action within the twenty days after receiving the rescission notice, before its deadline to return the consumer's money or property and record the termination of its security interest (15 USC 1625(b)).




