ELIGIBILITY: Only handcrafted work by the selling artist is acceptable. No kits, commercial or mass produced work allowed. The jurying will be divided into the following categories (please give explanation): 1. Paintings, Drawings and Prints; 2. Ceramics, Glass & Sculpture; 3. Fiber arts; 4. Leather and Wood; 5. Photography a. wildlife b. other; 6. Jewelry; 7. Miscellaneous. The jury will select 80 artist and craft booths from these categories. The decision of the jury is final. No raffles or drawings, other than those held by Copper Village Art Center will be allowed.

FEES: A fee for a 10x12 space for three days will be \$175 for the art/craft booth. This fee includes security for Friday and Saturday all night. The \$175 fee is due with application. If you are not juried into Art in Washoe Park, a full refund will be returned with the notification letter.

BOOTHS: Set up for booths will be 1:00 p.m. Thursday and 9:00 a.m. Friday. Please be prepared with proper shelter if rain or wind should occur. Bring your own tables. There is no access to electricity at booth spaces. No stakes allowed in ground due to underground sprinkling system. **Vendors will remain open until 4 p.m. Sunday.**

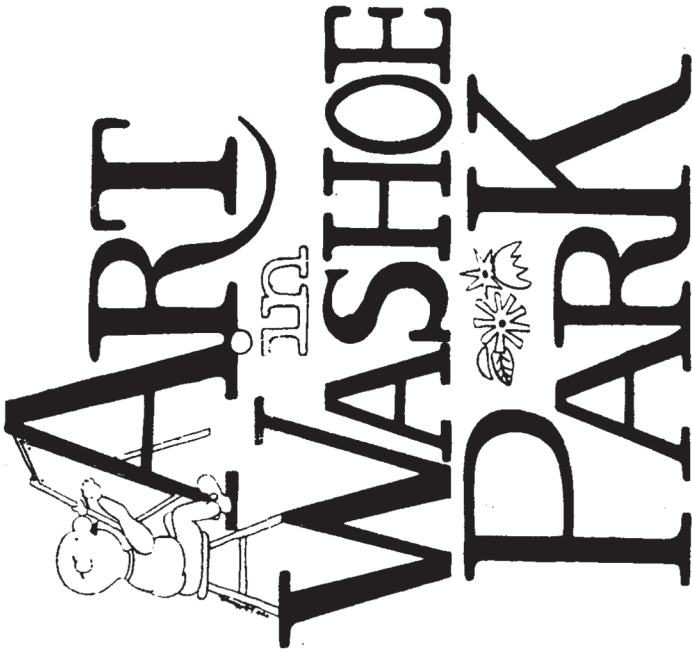
