DECLARATION OF VALUE NOTICE

The shipper/customer must select one of the options below prior to the start of any packing or moving service. In the event the shipper does not select one of these options, the carrier's maximum liability for loss and damage shall be an amount equal to a maximum value of \$0.60 per pound per item as described in Option A. All Claim limitations and Exclusions shall be applicable regardless of the level of coverage.

A	<p>RELEASED VALUE of \$0.60 per pound per article. This is the most economical protection and there is no charge for this option. THIS OPTION IS AFFORDABLE MOVING'S DEFAULT COVERAGE OPTION.</p> <p>Released Value Defined The most economical protection available is Released Value, since it is offered at no additional charge. However, the protection is minimal. Under this option, the mover assumes liability for no more than 60 cents per pound per article. For example, if your mover lost or damaged a 10-pound stereo component valued at \$1,000, you would only receive \$6.00 in compensation (60 cents x 10 pounds).</p>
B	<p>FULL VALUE based on a <u>maximum declared value of \$6.00 per pound</u>. THIS OPTION COSTS \$33.00 PER TRUCKLOAD AND MUST BE REQUESTED <u>BEFORE</u> ANY COMMENCEMENT OF MOVING OR PACKING.</p> <p>Full Value Defined Under Full Value Protection, your mover is liable for the replacement value of lost or damaged goods in your entire shipment. This is the more comprehensive plan available for the protection of your belongings. If any article is lost, destroyed or damaged while in your mover's custody, your mover will, at its discretion, offer to do one (1) of the below for each item:</p> <ol style="list-style-type: none">1. Affordable Moving will pay to repair the item in order to restore it to the same condition it was in when it was received <i>or</i>2. Affordable Moving will replace the item with a similar item as the one being claimed <i>or</i>3. Affordable Moving will make a cash settlement for repair or the current market replacement value of the property when it was received by Affordable Moving. Whichever option is less. Depreciation will be applied to all claims. The charge of this option will be \$6.00 per \$1,000.00 of valuation. <p>Under this option, movers are permitted to limit their liability for loss or damage to articles of extraordinary value, unless you specifically list these articles on the shipping documents. An article of extraordinary value is any item whose value exceeds \$100 per pound (such as jewelry, silverware, china, furs, antiques). Ask your mover for a written explanation of this limitation before your move. The exact cost for Full Value Protection varies by mover and may be subject to various deductible levels of liability that may reduce your cost. Ask your mover for written details of their Full Value Protection plan.</p>

LIMITATIONS & EXCLUSIONS:

Limitations:

- Liability for any claim on any single item shall not exceed \$300.00
- All damage claims must be made at the time of move
- It is the customers responsibility to inspect all items before signing satisfactory of move statement

Exclusions:

- Furniture composed of particle board or press board.
- Lamps, lamp-shades, pictures, mirrors, artwork, glass, marble, vases or statues not packed by Affordable Moving.
- Items found broken in boxes not packed by Affordable Moving.
- Mechanical condition of electronic, audio/visual, computer, or battery operated equipment in transit or storage.
- Previously damaged or repaired items.
- Previously damaged or loose veneer.
- Furniture with the original glue dried out.
- Any loose items not boxed.
- Plants (live, artificial, or dried).
- If one item in a set is damaged, only that one item is covered by the insurance, not the whole set.
