

# Hershey Music Festival

We will, once again, be participating in a music festival to be held on **Friday, June 1, 2018**. The festival is being hosted by *Music In The Parks* (MIP) and will take place in the Hershey, Pa., area.

Each group will perform two musical selections for professional musicians/judges and will be critiqued on their performance. They will receive recorded and written evaluations of each performance with tips and ideas to help enhance and improve the work that they already do. When the groups are finished performing, the students will get to spend the rest of the day in Hersheypark!

After a fun-filled day in the park, we will end with an awards ceremony filled with trophies and special awards and a lot of excitement! It truly will be a day to remember.

**The cost of the trip will be \$125.** This fee includes the festival registration fee (Hershey Park ticket, trophies, facility rentals, judges fees), charter buses, t-shirts (be sure to indicate shirt size on last page) and incidentals. To make the trip more affordable, we will accept payments in two installments, if you so choose. Please complete the attached commitment and insurance forms and enclose your payment of either **\$60** (second payment of **\$65** due **February 9**) or **\$125 total (CHECK ONLY! Cash WILL NOT be accepted)** made payable to **Rosa International M.S.** *If for any reason the cost of the trip becomes a concern due to a financial situation, please be sure to contact your director. Our wish is that every student enrolled in the music program has an opportunity to attend this event.*

It is important to remember that every student participating is expected to be a member in good standing of his/her ensemble. The entire year is spent developing musical skills and working together as a team towards excellence in performance and, hopefully, receiving placement trophies in the festival competitions. Therefore, it is important to be a productive member of the team. Any student who is removed from the ensemble for discipline reasons or lack of preparedness/lack of participation will **NOT** be permitted to attend the festival and payments **WILL NOT** be returned after the initial festival deposits have been made.

The 1<sup>st</sup> partial payment (or full payment, if chosen) **and completed forms** MUST be received **NO LATER THAN Friday, December 15**, in order to make the necessary payments to the bus and festival companies on time. **No exception will be made for anyone who does not turn in their payment/paperwork on time**, so please be sure to address this in a timely manner.

If a parent would be interested in spending 15 glorious hours with over 250 enthusiastic middle school kids as a chaperon, please indicate your desire to do so on the attached permission form. We are hoping to have at least 20 parents attend in order to provide a safe student-to-chaperone ratio. If we get more volunteers than needed, chaperones will be selected on a first-come-first-served basis. Do not make official plans to chaperon **until you have been notified.** *No payment will be needed at this time. Again, please do not send in a chaperon payment.*

Dear Parent/Guardian,

On **Friday, June 1, 2018**, your son/daughter will be on a field trip to Hershey, Pa., where he/she will perform in a festival and then spend the rest of the day in Hershey Park. In the event of an emergency or accident, it is important that medical care can be provided as quickly and efficiently as possible. In order to administer emergency services of any kind, your child must have a consent form with the proper insurance information and your permission for medical care.

Also, if your son/daughter requires medication to be taken during the time in which we will be away, you must complete the bottom of this form, as well. A nurse will be available to administer any medication. However, it is important to understand that even Tylenol/Motrin/Advil cannot be given without the proper paperwork being completed. It would also be important that only medications that are absolutely necessary be taken on this day, as the nurse will not be able to reach everyone in the event they forget. She will be stationed in an assigned area of the park and available throughout the day in the event her services are needed.
