I also understand that membership in this organization may be terminated by the endorsers of my application if I fail to comply with the rules set forth or fail to learn the music for the reseating auditions. All-State Intermediate Orchestra members are expected to attend all rehearsals and the concert; however, up to one half of one rehearsal can be missed (up to 2.5 hours) with permission from the manager *in advance* of the rehearsal unless that is clearly impossible. ***The concert day cannot be missed.*** This will be strictly enforced. No other absences will be permitted for any reason. There are no exceptions to this rule. I further understand that as an All-State Intermediate Orchestra member, I must remain an active member in good standing of my school orchestra/performing ensemble throughout my All-State experience and fulfill all requirements of my Junior Region Orchestra.
