## ABOUT OUT TO PASTURE ANIMAL SANCTUARY

Out to Pasture Animal Sanctuary is a nonprofit organization based in Estacada, Oregon. We provide a safe haven and permanent home for animals who have been rescued from abuse and neglect, including animals who were saved from laboratory experiments or who would have otherwise been sent to slaughter. We're often the last stop for the animals "nobody else wants."

Out to Pasture also helps animals throughout the Portland area through partnerships with rescue organizations by arranging adoptions and foster care for pets and livestock. We are also a trap depot for the Feral Cat Coalition of Oregon.

Out to Pasture is a no-kill sanctuary, and every animal is given the special treatment and extra care they deserve. Your support will give these animals a second chance at life by providing veterinary care, housing, feed, and other expenses required for the lifelong care of an animal.



## OTHER TYPES OF PLANNED GIFTS

These are a few planned giving options that a professional financial advisor can help to organize.

**Charitable Remainder Trust:** Earn a current income tax deduction for a future gift to Out to Pasture Animal Sanctuary. The value of the gift is based on current market value and offers you income now at a desired percentage.

**Charitable Lead Trust:** The trust pays income to Out to Pasture for your lifetime or a specified number of years. Assets are later transferred to you or your beneficiaries at reduced or eliminated estate taxes.

**Charitable Gift Annuity:** You will receive a fixed income for life and remove assets from your taxable estate.

**Revocable Living Trust:** Control the distribution of your assets, including bequests to Out to Pasture Animal Sanctuary, without going through probate.

## THREE SIMPLE WAYS TO HELP ANIMALS

**1 Outright Gifts:** Your gift of cash, stocks, or real estate will give rescued animals the good life they deserve.

**2 Bequest:** A gift of cash, securities, or real estate in your will lets you establish a legacy long after you're gone while avoiding costly estate and gift taxes.

**3 Life Insurance Policy/ IRA Beneficiary:** You can name Out to Pasture Animal Sanctuary as a beneficiary on a new or existing life insurance policy, or designate a portion of your IRA or pension in your will. The process is fairly simple and is available to individuals at all income levels. Plus your gift will be made with pre-tax dollars.
