**Membership Agreement**

**Court Fees**

Memberships are non-transferable and non-refundable. Court time, lessons, programming, and other expenses are separate and are not covered by the Program Only or Silver membership dues. For Gold members, court time is covered by the Gold membership dues. Lessons, programming, and other expenses are separate and are not covered by the membership dues. Pueblo Tennis Center rates and policies may change without prior notice. Management reserves the right to cancel a membership at any time.

**Auto-Renewal**

I, the undersigned, am taking out a membership at the Pueblo Tennis Center. I agree to pay my membership in accordance with the one-time payment option, or the Month to Month payment option. I agree to pay a \$250 non-refundable initiation fee, if applicable. I have read all of the Tennis Center's policies and regulations (located at [www.pueblotenniscenter.com](http://www.pueblotenniscenter.com)) and the waiver on this contract, and I agree to abide by them accordingly. I understand that tennis membership fees will be automatically renewed at the conclusion of each one-time payment, or the month-to-month option. If I do not wish for my membership to renew automatically I must notify club management a minimum of 30 days prior to the expiration of my membership.

**Membership Termination/Freeze**

I understand that any cancellations or changes made to my membership must be done so in writing. I understand that if I cancel my membership for any reason before the conclusion of this contract, I will be required to pay an early termination fee of \$300.00. I understand that if I freeze my membership during this contract period, I will be assessed a membership freeze fee of \$300.00. To re-activate my membership, I understand I will have to sign a new contract equal in length to my former contract. I understand that if I make any other changes to my membership, I will be assessed a \$100.00 change fee to do so. I understand that if I cancel my membership for any reason, I will be required to pay a current initiation fee if I decide to rejoin The Pueblo Tennis Center at a future date.
