TERMS AND CONDITIONS:

Please complete this enrollment agreement and return one copy to SBA and KEEP one copy for your file.

Tuition covers approximately half of the cost of a student's education; therefore, it is imperative that tuition payments are paid on time in the interest of the school's operating budget. Tuition payments are structured to be paid one month in advance.

A **\$150.00 (grades K-6) or 200.00 (grades 7-12)** non-refundable *Registration Fee* (per child) must accompany this form in order for your child to have a seat reserved for the school year indicated on the top of this form. If classes fill up, seats are awarded on a first-come, first-served basis. A \$50 discount is given for enrollment fees paid before June 15.

Charges to the student(s) account for tuition, room and board are due on the 20th of each month. Tuition payments received after the last day of each month will be assessed a \$25.00 late fee. Accounts that are delinquent will result in student dismissal as per Board policy, unless special arrangements with the superintendent are made. Therefore, fees and other expenses are to be paid in a timely manner since Sunshine Bible Academy has an obligation to its employees and creditors.

All withdrawals must be made in writing and shall be effective when such notice is delivered to the school. No special agreement shall be in effect unless it is in writing and signed by the superintendent. At the end of each school year or early withdrawal, all checkout forms must be complete and all financial obligations taken care of before transcripts/report cards will be released.

In order to maintain a proper Christian atmosphere, the school distributes rules and regulations, each of which shall be binding upon any student admitted to the school. Any student may be suspended or dismissed at any time in the event of gross misconduct, willful or repeated breach of rules, or if in the opinion of the school, such suspension or dismissal is in the best interest of either the school or the student.
