2. Purpose of Data Processing

We collect and process data for the following reasons:

3. Saved Data

We allow anyone to visit our client website without providing any personal data.

For better performance and to guarantee our website's functionality, we process the data transmitted to us by your Internet browser. These include the date and time of your visit, browser settings, the operating system and the IP address. This information is used for technical purposes only.

To enable us to respond to requests for additional information we will ask you for your name, phone number and/or email address. This information is kept confidentially and is and will never be shared or sold to third parties.

You can, at any time, request to know what information we have about you, ask us to update or delete this information. To do this please contact us (see contact methods section1).

Any clients that express an interest in buying a property with us may furnish us with additional information. This information includes budget, area of preference and properties of preference.

4. Data Security

7. Use of Cookies

Sunsoka Property uses cookies on some of our website. Cookies are small text files that are sent from our web server to your browser during your visit to our website that are stored by this on your computer for later retrieval.
