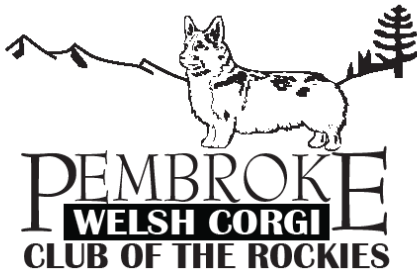

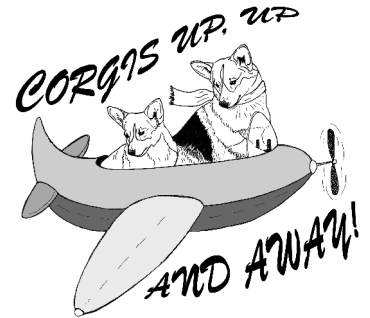

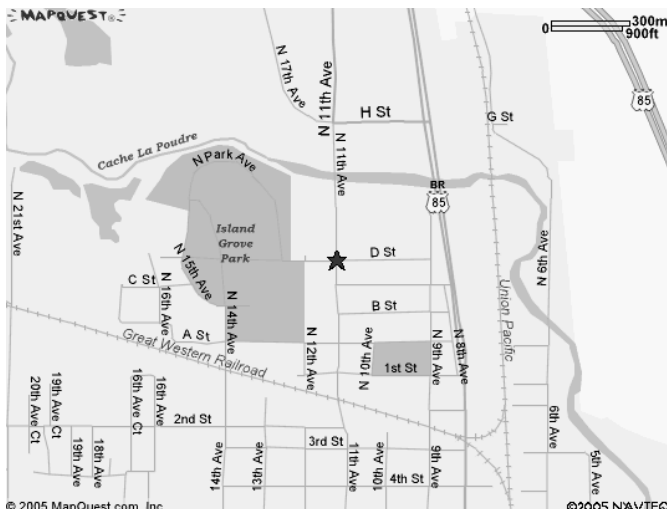

### **From I-25**

**Take the Highway 34 Greeley exit and go east to 35th Avenue. Turn left (north) and go to 10th Street. Turn right (east), and go to 14th Avenue. Turn left (north) and follow 14th Avenue into Island Grove Regional Park.**

### **From Highway 85**

**Follow Highway 85 north into Greeley. Highway 85 turns into 8th Avenue. Go to 5th Street and turn left (west). Go to 14th Avenue, turn right (north) and follow 14th Avenue into Island Grove Regional Park.**
