and 'Billy' Eduard Albert Meier, BEAM**

**Asket:** You are really surprised for once, Eduard ... it has to be.

**Billy:** Yes, ... Your surprise is ..., I really didn't expect that, be very welcome. You too, of course, Florena and thank you for having Asket ..


**Asket:** We thought that I should answer your question myself.

**Billy:** Oh, yes, - you must be thinking of my forgetting, for which I asked Florena if she could ask you about it.

**Florena:** I did, of course, and ...

**Asket:** Yes, and so here I am.

**Billy:** Yes, - thank you very much for coming here. Were you already here yesterday, because now it seems to me a little strange that you, Florena, called me and said, you would fly past and would want to greet me, by letting your aircraft become visible briefly. Seemed a bit strange to me, but I immediately followed your call, grabbed my little photo camera that has been lying around with me for 4 or 5 years, which I have only needed once for 2 shots. Of course, I immediately ran out and consequently was able to snap 3 pictures behind the kitchen when you opened the privacy screen of your beam ship. Unfortunately, they did not turn out well, whereby I obviously adjusted something at the shutter release when snapping, because I did not know that a zoom function is also operated with it. Then just at the same moment Andreas came out of the kitchen and asked if I had photographed a beam ship, which had happened exactly at the moment. And look here, these are the 3 pictures I could take. When I enlarged them in the computer, which Michael did, because I don't know anything about it and I'm an effective loser, it turned out that the pictures had a grid pattern on the one hand, and on the other hand the 3rd picture had some kind of ray formation. Can you explain this? - Look here, these are the 3 photos, for which Michael has written a short explanation.

**Florena:** What you have photographed, I have not noticed, and your question concerning the lattice pattern I can also not answer, because with the photographing technique I have never occupied myself and know therefore about it I have nothing to explain. However, as far as the radiation you mention is concerned, it is, as I see here in the picture, the effect of the protective screen which occurs when it is dissolved.

**Billy:** Well, thank you, that explanation is enough for me, Florena. Then I'll open the computer, and you can get a first glimpse of what James Moore has achieved.

**Florena:** We can do that later, because I ...

**Billy:** Sorry, this is my secret phone, let's see ...  
... Sorry, it took a while.

**Asket:** At this late hour ...

**Florena:** He often has such late calls, even when I'm here alone or with Enjana, it often happens ...

**Billy:** Yes, that's just the way it is.

**Asket:** Your help is often sought, as I have been told. Apparently, all the people contacting you do not trust the public state announcements, as well as the public media. But you knew that already in 1954, when you spoke about this now planet-wide prevailing plague, for what ... And that you have given no information to certain questions, but only advice, that ...

**Billy:** Excuse me, actually everything that has been said so far belongs in our conversation report when I call it up, but I will have to omit some things because I am not allowed to say anything about them. This also applies to what I had to keep quiet about on the phone.

**Asket:** But why didn't you answer the question about behavior with regard to immunization?

**Billy:** I suppose you mean the question of the woman, whether she had herself vaccinated, and with which preparation

**Asket:** Yes.

**Billy:** This is something that Sfath has already told me that I should never do such a thing, and I am not allowed to do it, because every person must and has to decide everything himself in every case and in every relationship, no matter in which matter and in which matter, and therefore he should not let himself be influenced in any way by a third party. But exactly this, girl, you also said, and I have kept to it during my long life and have done well with it.

**Asket:** I remember that, Yes.

**Billy:** Exactly. So I cannot and must not allow myself to tell or even advise any person whether he should be vaccinated or not, because in any case this must always be and remain his own decision, this also because it would be irresponsible, because a positive or negative effect or non-effect can be connected with a vaccination, or even late effects can occur, which only days, weeks, months, years or even decades later in some way come to an outbreak, whereby then it can not even be determined that it is a late effect of a vaccination or other previous medication, etc.. is involved. So I must not get involved in any case to give an advice to a person whether he should be vaccinated or not, consequently everybody has to think about it himself and to make up his own mind what he wants to do or not. Well, if I now refrain from vaccinating and only consider simple aches and pains, such as headaches, etc., which are just temporary ailments, then that is something different, because here and there I can give advice from my own experience, such as for a healing action or a natural remedy or something.

**Asket:** That will probably be so, but I would be interested in what you can explain in more detail regarding the worldwide spread epidemic and the protective measures against it.

**Billy:** I think you mean vaccines and inoculations and so on?

**Asket:** Yes.

**Florena:** I would also be interested in your knowledge?

**Billy:** If that's that important to you! - - Well, on the one hand I have already said that I am not allowed to give advice or requests about anything. So I can only try to explain a few things, although I think that you - but Heiri is like sausage - so I just put everything together that I can think of and I think what should be said once:

What can be expected from and after a Corona vaccination, what risks are associated with it, this has been discussed many times over the course of time between Ptaah and me. Consequently, you probably know that too, which is why it does not need to be repeated. So then I can talk about other things, such as. about why everything went so fast, how irresponsible people made horrendous profits with only distilled water and salt solutions as alleged vaccines, which claimed many dead, what however was neither determined until today and consequently also could not be made known, because just nobody cared about it, because nobody cared about the reality, nobody thought further and also had no interest in getting to know something else than only just what happened officially momentarily interesting and sensational in the fate sky etc.. The principle was and is also furthermore always the same: <What I don't know, doesn't make me hot.> Nobody wants to know what really happens and is, what is going on and what will arise and result in the future. Therefore, through the pandemic of the Corona virus plague, corporations can also rake in immense monetary profits through the fear and uncertainty of the people through vaccines and effectively test their not yet really tested vaccines at the expense of the

health and life of mankind to this day, which they otherwise have to do with special test subjects who are willing and willing to pay. This is precisely in order to test the vaccines to be produced in detail in trials lasting many years until they are developed into effective vaccines.

1. Basically there is no security for every medicine and therefore also for every vaccination, because all substances of this kind have side effects sooner or later, therefore also the vaccines against the Covid epidemic are no exception. Furthermore, all the Corona vaccines are new and untested, therefore only now millions of people are being used as test subjects to gain experience with the rapid vaccines through free mass tests, but despite millions of vaccinated people, the test results are very limited and, moreover, many deaths are to be deplored through these tests. And this is an undeniable fact, which makes many people unsure and consequently they shy away from such vaccinations.

2. What Ptaah and his colleagues have summarized in relation to a Corona vaccination, precisely what can be expected after such a vaccination, what risks arise from it and why these new vaccines have now been made available so very quickly, corresponds on the part of the vaccine manufacturers not only to an irresponsibility, but to an unparalleled profiteering at the expense of fear, anxiety and the abused trust of the populations in medicine.

3. The Corona vaccine is not safe in any way, as the Plejaren research indicates, because it is unexplored. It normally takes Earthlings up to 15 years or more to develop new vaccines on a responsible basis. This would also be necessary with regard to the Corona virus, whereby, however, after less than a year after the outbreak of the pandemic, a vaccine was made available for dubious and fatal use - as a super-premiere, so to speak. This action and its consequences made many people insecure, because instead of maintaining safety and doing everything necessary to contain the Corona epidemic, science and the authorities failed, did not do the right thing, and also acted inaccurately and irresponsibly.

All the vaccines and medicines for the control of the corona epidemic were simply thrown on the market without being rigorously tested for their safety before being approved, because all the manufacturing companies did not carry out all the necessary studies, as the responsibility and the life safety and health of the populations would have demanded in the first place.

4. Everything had to happen fast and quicker, which was mainly due to the fact that the WHO and the sciences had been asleep and had not switched gears early enough when the first Corona cases appeared already in the mid 1970s, which however were not recognized as such, but were wrongly judged as flu variations, again and again over about 4.5 decades, during which the Corona virus mutated about 5000 times. Finally, in January 2019, the first effective disease outbreak occurred in China, which was not recognized as a Corona virus, so that the whole thing could spread until November or December as an effective Corona virus disease form and lead to a pandemic, which was nevertheless not recognized as such until December 2019 in Wuhan.

5. The development of the Corona vaccine was said to have been undertaken quickly because of its urgency, and rapid steps were taken toward a parallel approval of new vaccines, rather than the sequential process that is usually followed. This has cost more than usual, but has saved valuable time. In this connection, however, one wonders what this joke statement is supposed to say in connection with <quickly invested large sums of money for the approval of new vaccines>. Excuses were given that some research findings had already existed, namely in the way that there had been a close relationship between the Corona virus and the SARS virus that appeared in 2002. This SARS virus then disappeared again - and as Ptaah said, according to the Plejaren research there was no connection between this and the Corona virus. In any case, it is claimed, the alleged preliminary work helped the

vaccine manufacturing companies to find an effective vaccine against the Corona virus after <very quick> study results. This is also said to have resulted in the presentation of a new Corona vaccine that proved the efficacy and safety of a good vaccine. So it was reviewed by independent regulatory authorities and approved immediately. Such a procedure is called <rolling review>, which I looked up means <a procedure is continued until relevant data provide sufficient results to allow formal approval and risk-benefit value to be identified and use to be allowed, where a If an acceleration of a matter takes place, the requirements for this must be high in terms of quality, safety and efficacy.> However, I do not know to what extent this was and is actually the case. But I do know that all vaccines that have been used so far and are still being used, have not been tested correctly, neither to the last detail nor for negative effects or late effects or even long-term damage to health, as I know from Ptaah.

6. What has been explained under the 5 points so far is only a part of the whole, while the manufacturing companies and authorities claim, however, that they cooperate particularly efficiently and flexibly and therefore have accelerated the process, which otherwise would have taken years, what is denied by you Plejaren, however, because this is not possible and consequently products created in such a way could in any case in one and the other case cause severe health damages, as e.g. also coronary vessel inflammations etc. or by other organ diseases caused by the vaccines even death in many cases. Nevertheless, a conditional approval was granted for the vaccines at an early stage and will continue to be granted, although they are not fully developed and consequently research on and with them is ongoing. Of course, the manufacturing companies gain more and more new data and also new safety and efficacy of the vaccines, but at the expense of many lives of people who are used as test objects - often out of fear, for which they have to pay with long suffering, diseases or death. And that thereby all around the world the governing have completely failed from all beginning in their government incapacity and continue to fail completely, consequently they could stop the whole of the epidemic neither at the beginning of the emergence, nor can stop now, because they do also now opposite the correct, what should be done, explicitly the wrong, so the 1. wave of the mixed mutation can take hold now. Wave of the mixed mutation can reach around, of what Ptaah has warned already some time ago that this will come, about what also in a contact talk was talked and the whole then in the Internet was switched on and announced. However, all <smart> of the virology, epidemiology and the governments etc. did not care about it and continued to muddle along in the started useless framework, as they still call the new wave of the new mixed mutation the 3rd wave, although it is the 1st wave of a new epidemic form.

7. Banally, in response to doubting questions, the vaccine manufacturers claim that reactions to vaccinations are completely normal, which can actually be so according to the health constitution of man, as Ptaah and Plejaren scientists etc. confirm to me, but it is completely abnormal that long-term damage or even deaths are associated with it. If this would be the case, then this would be an irresponsibility like no other, because then the corresponding vaccines would not be what they should be.

8. As I know, it turned out e.g. that after a Corona vaccination with the vaccines of Biontech/Pfizer, Moderna and Astra Zeneca (as of February 2021) most people had inflammatory reddening at the injection sites or pain, swellings or other complaints and even bad reactions as well as fever, swollen lymph nodes, nausea or generally feelings of illness, as was stated by Pleiaren. And that, Ptaah said, usually affected up to 9 out of 10 vaccinated people. How often such reactions occur today, I do not know, because Ptaah is absent, and so I do not have any new information, not even about how many people have died or are currently dying due to vaccination problems.

9. while I am talking about these things, it might be good if I also explain something for all the people who read our reports, because I have often experienced in my life that many people do not know what vaccinations actually mean, what they do and how everything works. Many people also don't know what the immune system actually means, which is why I think that I should at least explain what I have learned and what I know, which might make the whole thing a little easier to understand for some people. Unfortunately, this is not usually explained by doctors etc. to their patients.

a) Also: The immune system is the physical-organic defense system that ensures that pathogens of all kinds are fought and an infection is prevented when bacteria, germs, fungi, parasites or viruses enter the body organism.

b) However, the immune system is not a separate organ, but the colon must be emphasized.

c) The immune system corresponds to a necessity of life, because it protects the body organism against pathogens and pathogenic cell changes and generally against harmful substances of various kinds, whereby it comprises in this respect different proteins, organs and cell types, whereby it does not make itself recognizably noticeable for humans in the normal state of health, but then explicitly, if pathogens of any kind attack the organism. Repeating is to be said thus that, as long as the bodies own and evenly the immune defense functions smoothly, this does not make itself be noticeable.

d) To the immune system belong primary lymphatic organs, to which also the bone marrow and the sweetbreads belong, which is actually called thymus. The thymus as a primary lymphatic organ is located in the thorax behind the sternum, if I remember correctly how Sfath explained it to me it's just been a long time since then, which is why I can't remember everything exactly.

The sweetbread, however, I do remember, is something that increases in weight during childhood up to about 40 grams or so and also in size, but which recedes after puberty. The sweetbreads, where T-cells which are called T-lymphocytes or something like that and correspond to a group of white blood cells that mature in the sweetbreads - serve the immune function, where these T cells, if I'm still putting it together correctly, together with B-lymphocytes, create an acquired immune response.

The whole together forms certain defense cells, the so-called lymphocytes, which correspond to secondary lymphatic organs, to which the lymph nodes as well as the tonsils and the spleen belong, as well as certain tissues in various mucous membranes of the body organism, such as the intestinal system.

The immune function and thus the defense against pathogens by the immune system of the entire human organism include entire organs, such as the blood, the body skin and the mucous membranes, the vascular systems, the lymphatic channels, the so-called lymphatic organs, but also proteins and individual cells, and especially the colon. I remember that Sfath pointed out that certain organs, such as the skin and the mucous membranes, have a barrier function against pathogens, whereby they have a protective function against pathogenic harmful substances and parasites that penetrate the body and its internal organism from the outside. Sfath explained that the whole defense strength of this natural protection factor can and should be additionally supported and strengthened with certain natural means in case of deficiency symptoms, namely by supplying the body with special substances necessary for the whole organism in addition to the normal food. Nowadays, such substances are produced as food supplements and are available in the free trade. However, when buying such products, one has to pay attention to a really good quality, because there is a lot of shenanigans and fraud for making profit with such means. Consequently, it is highly advisable to take the precaution of purchasing such products only from specialized dealers.

What has to be taken into account is the fact that today's commercially available foodstuffs of all kinds are on the one hand contaminated with harmful substances that are hazardous to the health of the

human organism - more or less also organic products, although this is denied - or correspond to practically purely chemical products, which nowadays make up a predominantly large part of the food offers for humans in the food trade.

What is further to be said about this corresponds to the fact that certain physicians, doctors and <nutritionists> untruthfully deny the entire facts of the necessity of additional food supplements for certain people who need such substances because there are too many toxic substances and too few effective natural valuable nutrients in today's food, consequently many people need certain of these food supplements. However, as said before, caution is required when procuring them, because there is a lot of fraud and deception with these means, therefore such products should only be purchased in specialized shops.

Food supplements basically correspond to specially produced products for the increased supply of the human metabolism. These contain certain nutrients or active substances, mainly vitamins and minerals, trace elements and secondary plant substances, etc.

The mucous membranes contain bacteria-inhibiting substances, as in the respiratory tract the ciliated hairs, in the tear fluid of the cell walls, as well as in the mouth saliva many inhaled pathogens are eliminated at an early stage, because these get stuck and are usually removed or destroyed again. Many other pathogens that are ingested through food and are present in Many other pathogens that are ingested with food and enter the stomach are also destroyed at an early stage by gastric acid before they can cause any damage.

What is to be said now, however, that refers to the fact that the bulk of the immune system resp. its defense cells is located in the large intestine, so at least I remember what Sfath taught me, but what Ptaah also recently explained again. In the case of vaccinations, these react in the same way as in the case of an actual infection, whereby people who react sensitively to vaccinations can feel the immune system becoming active. This is why these people may feel unwell and sickly for a few days, as I know from my own experience when I had to be vaccinated against cholera etc. in the Orient or in Africa. Slight fever, nausea, feeling sick or headache etc. can be normal consequences of vaccinations, because vaccines trigger the corresponding symptoms of disease, whereby the immune system starts to work against them and to produce defense substances. Such temporary symptoms are normal and are part of the natural immune system reaction to vaccinations, but they usually last only a few days, are usually mild and usually disappear quickly.

With really thoroughly tested and effectively effective vaccines - so I know from Ptaah, and I can rely on his explanations, just contrary to those which our earthling <experts> announce no severe side effects occur at all. In fact, with certain currently used vaccines, severe side effects do occur from time to time, which is the case with vaccines that have not been sufficiently tested and are not of effective quality. Although it is claimed that there is currently no evidence of severe side effects with any of the approved vaccines, the reality proves otherwise, as one hears again and again from various places. In very rare cases, an allergic or anaphylactic shock can occur directly after the vaccination, as Ptaah said, because he had observed that with Corona vaccinations, in addition to various other vaccination damages, such as heart disease and various other serious damages, long-term suffering and just mentioned shocks, etc. occurred. This on the one hand, as he said on the other hand also that by vaccinations also after several decades different health damages will occur, whose cause however no more can be fathomed. In the case of allergic reactions, so it is claimed, it is a question of such reactions occurring in people who had already suffered from such phenomena in the past, to which he said, however, that this only applies to about 25-30 percent of such cases, which, moreover, had also reacted allergically to certain medications, consequently the majority of such allergic reactions in people affected by them is due to an <impure> or not fully developed vaccine.

As far as allergic reactions are concerned, there will also be vaccine-related delayed or subsequent side effects, which could consequently also show themselves in the long term as damaging effects on the

body, about which, however, he cannot yet say anything precise. Delayed side effects with negative long-term consequences are unavoidable as a result of the irresponsible use of insufficiently tested vaccines, and there is currently no precise knowledge of their effects, but these effects will inevitably occur, the causes of which cannot be explained. Irresponsibly, Ptaah said, it is simply claimed that such delayed side effects are not very probable, but the future will prove the opposite, and the effective causes will then be attributed to wrong causes. Also the fact that Ptaah has declared - contrary to all other claims of the earthly experts that according to the Pleiaren research results the applied vaccines in different cases exert a certain influence on the DNA resp. on the genetic material of people, this is simply denied. It is simply said that it is improbable, even though no research has been done in this regard and no knowledge has been gained, that human DNA is not influenced or even changed by the corona vaccination and such an unverified assertion is then simply taken as truth. It is simply asserted, unchecked, that the genetic information contained in the vaccine does not come into contact with human DNA - and that's that - and that is simply the case because it is well packaged in the cell nucleus and therefore cannot be affected. This applies equally to the genetic material in the female egg cell and in the male sperm, because none of the vaccines have any effect on them. In addition Ptaah said that the Plejaren had not attained knowledge in this regard also yet, however, researches would pursue, whereby it is nevertheless negligent, unresearched simply a statement to set up, which is equally the case in relation to the fertility of the woman. The whole of such assertions would correspond to an irresponsibility beyond comparison, because in connection with the Corona vaccination no research had been carried out and consequently no relevant results had been obtained.

Well, what I have to say in the end is that not only vaccines, but also every medicine has side effects, so vaccination against the Corona disease is no exception. Moreover, and this is the main point, everything concerning the Corona vaccines is absolutely new and effectively completely insufficiently researched, insufficiently tested and still so limited in terms of accumulated experience that even today everything is not clear and not certain. In summary, this means that it is still not possible to know what will happen after all the millions of Corona vaccinations that are now coming and what can be expected, how, what risks will be associated with it and what will finally result from it. Also the question cannot be answered yet, which benefit or disadvantage for the whole earth humanity will result from the Corona vaccinations. And whether the Huschhusch-Corona-Vaccine heralding will ultimately prove to be a premiere or a derniere, that will not be revealed in the near future, but only in the more distant future. Talking more about it is pointless and would be like carrying water into the sea to fill it up.

Then I may ask you, Asket, now perhaps ...

**Asket:** What you say is probably correct. From Florena I already know what your question is about, not only about your forgetting, but I want to explain everything to you. On the one hand it is about different things concerning your own person, on the other hand it is also about some things concerning your ancestors, whereby I want to address your forgetting first.

Your youth was so bad for you that even today I cannot understand how you were able to cope and survive everything. You were in such a situation because of all the nastiness that was done to you that you went to the last step, but I was still able to prevent it and from then on I had to protect you from everything. In the end, I could not do anything else than to have large parts of your worst memories removed from you. We had to do this in such a way that all those memory parts which began to cloud your consciousness can never penetrate back into your memory for your whole lifetime. But we did not do it without permission, because together we discussed everything in detail, which required long conversations, but then you agreed to carry out an irrevocable causal elimination of certain memory parts. The reason for this was that you were more and more threatening to fall into depression and thus

into a mental illness. Your threatening illness has burdened you more and more, because you became mentally weaker and weaker and overstrained, but you tried to hide your condition to the outside by adopting a harsh behavior towards attacking activities, which many of those persons allowed themselves against you, who had been hired by cult members and paid with sums of money to drive you either into depression or to suicide, if you would not join their cult. In your youth you were not yet able to control the extent and the consequences of their evil machinations against you regarding the illness of your thoughts, feelings and your mental state in such a way that you could have consciously protected yourself in this respect by your own strength. If the whole could have expanded in you and become even more powerful, then your whole life task of your mission would have collapsed and become ineffective. That's why I had to intervene and to eliminate different phases of experience from your unusually shaped, constant memory from your memory. Your multi-media memories contained such pictorial elements, scenes and pictures, which ran in you like in a movie, whereby also sounds and tone colors as well as scents and smells were connected with it, but above all also such strong feelings brought you pain, which you were only able to control almost by force. All these memories resulted from your sequential long-term memory resp. from your episodic memory in which they were contained in a very strong compressed form and were activated and processed continuously, consequently they burdened you continuously and caused you agonies. The whole of your memories was almost photographic for you and so sharply perceptible that they became more and more a mental scheme and a life-like memory assimilation, consequently your memories turned out like reality fusions, which constantly increased and appeared to you like ongoing events. As a result of all this, you became morally more and more depressed, you lost your joy of life and any interest in your environment more and more, and you became seriously ill, which also affected your kidneys, which became severely inflamed and caused you great pain, which is why you wanted to visit a special hospital, but this was refused to you, as well as a normal visit to a doctor. This was because those members of the sect in your hometown who did not like you because of your disbelief in their God and wanted to see you either as one of their sect or as a dead person had all paid with large sums of money to harm you and in this case even to let you die. And this was so for many years, and indeed far and wide everywhere, where you were brought by force by persons of the administration of your hometown, corrupted by cult members, who as corrupters arranged everything evil against you. As a result of this, you were refused any medical help, because it was hoped that you would not be able to cope with everything and that you would not survive alive, which I could not and was not allowed to allow, because I had to bring you to Erra and there you could be healed and freed from the evil of your tormenting memories. **Billy:** And how did that turn out, can you say a little more about that, Asket?

**Asket:** The beginning of a depression which arose at that time was not a condition disorder and therefore also no weakness on your part, but the whole was based on your still given incapacity resp. the mental still not being able to control the attacks and malignities directed against you, consequently it was a matter of your condition about a disease in need of treatment which had attacked your central nervous system. This caused the onset of approaching depression, which triggered the whole thing in interaction with all the various factors acting on you and attacking your central nervous system. All the heavy psychosocial stresses, like also your heavy and very painful kidney inflammation, the constant stress by the attacks against you, as well as the biological-neurological processes in the central nervous system led to it altogether. As a result, your entire thought-feeling-psychic world was affected, which also severely affected your entire physical-organic well-being through the activity of the nerve cells in

the brain and your biorhythm. If these nerve messengers then fall out of control or out of balance, then the communication between the nerve cells fundamentally gets out of control, whereby a depression can develop. Namely, if not enough signals are transmitted from nerve cell to nerve cell, then the limbic system is affected, causing fluctuations in the biorhythm, such as, among other things, an impairment of the circadian wake-sleep rhythm, which has very strong effects on mental and physical function and their health, and which also controls the body core temperature, the necessary neurotransmitter output, as well as blood pressure and other bodily functions, and so on.

**Billy:** Thank you. - I can understand your explanation to some extent, but I would like to know more about it later to really understand it exactly.

**Asket:** Well, we can, but first I have to answer your question regarding the insults used in your hometown by malicious individuals against your parents, your siblings and against you in your youth. Indecent individuals, as well as individuals marked by depravity of character, who shouted at you, your parents and brothers and sisters level-less, as well as reprehensible, despicable and grievous insults, bothered all of you with it. These evil invectives led back in their origin to the year 1880, which resulted from hatred, as I had already researched in 1954. This hatred arose against the then 25-year-old Johannes Meier, of Niederflachs, your grandfather, whereby the cause arose from the fact that he married the 18-year-old Pauline, for whom another man was also inflamed, namely a traveling preacher, who at that time went from your hometown to England and joined there a religious movement, which had Methodist features, which had already found its fundamental beginning in England in 1738. When he returned to your hometown, he grouped a small religious sect around him, which comprised 11 members and to which the still young Pauline belonged. This small sect was shaped after the English model, thus after early Methodist features, called itself secretly <Christian Sanctification>, whose preacher tried already before the marriage of John and Pauline to win the young Pauline for himself, which she did not want, however, but turned to John. So the preacher tried to win John as another member for his sect, in order to possibly get to Pauline in this way, but his efforts were unsuccessful. Both refused steadfastly, and when they then married each other, the preacher flew into a rage and began to insult them both as <Dreckmeier>. After that, however, 2 other incidents occurred, for whose cause the vituperation was also brought to bear, which quickly became widespread and was then preserved in this way. This, as also the small sects could spread and win members and develop themselves methodistically, whereby I did not clarify however their further career, but only the facts, which arose then at your time against you by the criminal machinations of different secret and wealthy members of the established religious community, in which also several persons of the local administration were involved. Officially, all these people professed the two Christian churches in your hometown, Catholicism and Protestantism, while secretly and surreptitiously they belonged to the more and more established religious community, which the former traveling preacher had brought to your hometown from England. Since the population at that time was still strictly religious and also very fond of the belief in ghosts, miracles, charcoal burners, ghosts, devils and mysticism, many people often fell victim to illusions and imaginations, i.e. mental inner ideas, which at that time many people regarded as fantasies, illusions and fantasies, You called them fantasy and illusion, consequently they felt attacked in their religious faith and scolded you as <godless dirty man>, hated you viciously and even prayed that the devil should get you for your supposed blasphemy and

throw you in hell and purgatory. Altogether I could find out 34 persons, who were involved as strict Christian believers, sects and church members in all attacks against you, also collected considerable amounts of money among themselves and bought like-minded people with it, in order to corrupt you. And in this way they did, while others, for the sake of appearances, got involved at the same time with other denominations and tried to vote their members against you, as well as to bring them into their Methodist sect, and especially with three other denominations, which called themselves <Brotherhood> and <Salvation Army>, as well as that of the <Returned Christians>, which, however, did not come to light openly.

**Billy:** Thank you, Asket, that's enough for me, I didn't want to know more. What is important to me is that I now at least know why I no longer have a ghost of a memory of certain things and events etc.. But I remember that at that time you described the main sect as Methodist. But now something else: Michael has called me something in the Internet, of which I had no idea, and that is a website of James Moore. The question is, Florena, do you know it?

**Florena:** No, I have never dealt with such things. What is it about?

**Billy:** James Moore has a lot of information about us or about the FIGU, about contact reports, film and photo recordings, etc.on his site, all in German and also translated into English.

**Florena:** I would be interested in that. How can I find it?

**Asket:** I am also interested in it.

**Billy:** No problem, Michael gave me the data for it, so if you tap into the internet, the following search address applies:
