Further information on the Corona vaccinations Excerpt from the 770th Contact of Wednesday, May 5, 2021.

Bermunda I will talk about that later, if you really want to then, because first Florena should tell you the explanations ordered for you by Ptaah regarding the Corona plague, which he mentioned as significant to inform.

Florena This is indeed so, so I have to explain the following on behalf of Ptaah: Recently, the WHO and also certain European as well as American agencies will try to find out the origin of the Corona plague, but its origin cannot be fathomed and effectively does not want to be found, in order to keep the shame of betrayal away from America. Therefore it will be that several times deliberately wrong theses and assumptions are brought up, which are to prove that the plague is of animal origin. However, we will have to talk about this again and again. A further remark of Ptaah refers to unpleasant things from forecasts, which show that in the next weeks world-wide by state and authority decrees carelessly and irresponsibly the majority of all precaution measures and Lockdowns concerning the Corona epidemic are loosened and partly completely lifted. Thereby the populations of all countries are lulled into a false sense of security, which under certain circumstances can cause serious consequences, about which, however, according to his order, no mention is to be made, for which, however, I myself also lack personal knowledge. Ptaah stated that his foresight has shown that carelessly and irresponsibly, far too soon, even the safety of lockdown is being lifted and the non-use of respirators and non-resistance is being allowed, which in the context of new corona virus mutations could lead to further major outbreaks of contamination. Therefore, he recommends:

1. No one should get involved in these ill-considered decrees and irresponsibilities that will be issued in the near future by the state authorities, but should behave correctly and responsibly according to their own understanding and common sense in each situation that arises.
2. Respirators of class FFP2 should continue to be used when dealing with other persons who are not in the personally safe and disease-free handling area.
3. The necessary distance to other persons should be kept, especially to strangers, as the wearing of respirators of class FFP2, while in the circle of close acquaintances and friendships further distances are not necessarily required, if there is a certain security with regard to non-infection.
4. Not wearing respirators or wearing inferior non-FFP2, such as FFP1 and cloth masks, etc., should be refrained from, because they do not provide any protection against the Corona virus and all its mutations. Wearing inferior masks is not only negligent, but also irresponsible and also dangerous to health possibly life-threatening.
5. We cannot and must not give any advice concerning vaccinations against the corona disease, because the pros and cons are solely in the personal decision and responsibility of each individual person.

These are the 5 important things that Ptaah wants to have explicitly mentioned.

Billy I find everything right, good and right, but I have to say that we from the FIGU also adhere to it and give no advice, whether someone should be vaccinated or not. Effectively, each person must make it out with himself, use his intellect and decide everything personally after his own mature consideration according to reason and reasonableness.

Florena That must be so and is important. But now continue with what I have to explain according to the order of Ptaah: Worldwide, people were criminally abused without their knowledge as test objects for dubious and dangerous vaccine tests with the use of negligently test-less resp. untested corona disease vaccines. This inhuman and even criminal acting and doing of the corresponding chemical and vaccine companies has not only led to numerous negative effects and too much suffering, misery and suffering which is deliberately concealed or kept secret as many deaths and long-term illnesses, but also late effects, which will only occur after months, years or decades and whose origin and cause can then no longer be determined. This is in addition to the fact that various ailments etc. can be caused by the dangerous gene-based vaccines, whereby in individual people it cannot be predicted how, when, whether and which reactions will or can occur as a result of a vaccination. In addition, a certain part of the vaccinated people may not show any detectable corona symptoms, although they carry corona impulses in them, consequently changes in blood values may occur in them as well as in recognizably corona infected people. Our research also shows, as Ptaah explains, that spike proteins from corona viruses also cause blood clots, with D-dimers being formed as cleavage products in the blood.

Ptaah further explains that small thromboses can also form unnoticed, through which clotting platelets are consumed, as our research and findings clearly prove. Thus, the genetically engineered vaccines are absolutely not harmless, even if completely irresponsible claims to the contrary are made.

In addition to all that has been mentioned so far, there are numerous other different symptoms that result from the various corona vaccines in the human organism, some of which lead to death as well as to long-term damage and late effects, the cause of which, however, is concealed and denied, which will also be the case in the future. Consequently, deaths and severe side effects will occur far into the future, also as long-term consequences and late effects, the fundamental cause of which, however, will contrary to reality no longer be sought in the Corona epidemic as well as in the dangerous gene-based vaccines, which are used unconscionably and irresponsibly untested, mainly as a result of greed for money and profit of the vaccine manufacturers. And this unconscionably and irresponsibility is also given, if in different cases by vaccinations a certain immunity against the Corona epidemic can be obtained, whereby this can be on the one hand possibly only short-lasting or in such a way that nevertheless an infection can develop and be spread further, and this without that as a result of the vaccination an infection becomes ascertainable. This is also connected with the fact that impulse deposits of the epidemic result, which are carried on and can produce consequently in this way new infections, which can remain possibly over centuries and millennia and lead again and again to new mutations and to the outbreak of the illness, as that is similarly with influenza viruses the case. In addition Ptaah explains that this peculiar phenomenon is however absolutely unknown to the sciences responsible for it, because regarding illness impulse deposits scientific researches were never operated, as for it so far also all necessary possibilities would be missing.

Ptaah further explained that the vaccines used up to now, which have still not been sufficiently tested, are toxic and therefore have toxic effects. Among other things, the antibodies from these vaccines, some of which are very dangerous to health, are transferred to the colostrum or the colostrum of the female sex and therefore also to the hormone prolactin, which is essential for the formation of breast milk. This means, however, that through such infected mother's milk already newborns are infected with the Corona virus, whereby resulting from it also bleeding in the gastrointestinal tract can occur with infants. All these facts, however, as soon as they become known to the experts, in particular also

by the vaccine producers, are concealed and hidden from the common population, which, on the contrary, is animated to untested vaccinations, whereby unconscionably suffering and diseases and even the death of people is accepted, and all this only for the sake of the filthy profit.

In addition to all the information disclosed so far, it also emerges that spike protein develops in the human organism as a result of the Corona virus, which, as soon as it enters the bloodstream, can cause severe to irreversible damage almost solely to the cardiovascular system. In addition, Ptaah further explained, the pathogenic spike protein also overcomes the blood-brain barrier and also causes serious and irreversible brain damage, as well as blood clots and serious heart problems.

He further states that our research proves beyond doubt the penetration of vaccine nanoparticles into the body organs, they accumulate in the blood and concentrate very high in the bone marrow as well as in the liver, spleen and adrenal glands. In the female sex, our research clearly proves that vaccine nanoparticles concentrate in the ovaries and lead to severe birth defects in newborns during pregnancies. However, symptoms of this kind have been occurring since the first vaccinations, but this, as our observations and clarifications show, among other important information, is also concealed or denied to the public, such as the fact that as consequences of vaccinations often fever over 38 degrees as well as joint pain, abdominal pain, headache, diarrhea, fatigue, hearing problems, vomiting, dizziness, chills, nausea, shortness of breath and muscle pain, etc. can occur, up to life-threatening or even fatal effects.

These are some of the consequences of vaccination that can be mentioned, but they are determined by the negative susceptibility of the physical-organic constitution as a whole, e.g. by a mentally negative attitude and thus by a psychically negative constitution. Negative consequences of vaccination are mainly caused by the degree of effectiveness of the immune system, but this degree is mainly determined by the person himself, namely by his behavior in relation to his whole way of life. Mainly unpleasant susceptibilities concerning the immune system result from immunosuppression, because the body's own defense system resp. the immune system is forcibly suppressed by it. This is especially due to an organic disease or an excessive physical or psychological stress, whereby addictions are special risk factors and play a major role, but also a negative mental attitude, hypochondria, nicotine, an excess of caffeine and tea. Amphetamines, sniffing substances and even sports addiction, insufficient personal hygiene, tranquilizers, too little physical exercise, as well as the targeted consumption of alcohol, drugs and medications increase the susceptibility to infection, as do anorexia, bulimia nervosa, obesity, a wrong diet and eating disorders, etc.

There are various factors which I have to mention for this, how, among other things, besides a usual-normal transmission infection, a contagion of the corona disease arises as a result of further serious additional factors, for which the individual human being bears the personal responsibility with regard to his entire behavioral patterns etc.. And this corresponds to an effective fact, which, however, as we have known from our researches and observations since time immemorial, is denied by all <knowing> earthly special sciences of the medical faculties of all universities, as especially by virology, epidemiology, infectiology, immunology, immuno-hematology and psychology, because they are all too uneducated and too ignorant in these accruing disciplines and, moreover, also arrogant, as you once <admitted> to these persons.

What is to be explained further after instruction of Ptaah, that corresponds to the fact that the Corona virus like every virus at all persists resp. persists or remains permanently as pathogen for a long time, and indeed over millennia, because viruses once become active can well be contained, minimized and

brought to disappearance, but never eradicated. Contrary untrue statements of the earthly virology and immunology etc. correspond to an ignorance or a deliberate untruth.

After an infection the viruses, despite an effective serum antibody dilution, and the antibody carriers themselves form potential sources of infection. Virus multiplication is usually inhibited by vaccines, but the vaccine substances never lead to convincing results with regard to each individual virus species. Consequently, viruses can never be eradicated, but only paralyzed or their activity can be restricted for a shorter or longer period of time even over millennia, although they can become active again at any time.

If the pandemic contamination of the earthly world population is considered, then this is regionally differentially affected by the Corona virus and varies between the industrialized countries and the third world countries in every respect very strongly, because these developing countries are generally controlled by the state leaders, The developing countries in general are unrestrainedly disadvantaged and unscrupulously exploited by the leaders, companies and corporations of the industrialized and ruling states in every possible respect, and the Third World peoples are driven into misery, hardship and ruin, into hunger and even death.

Further I have to explain that dilutions for vaccines, for antibodies or antigens can only just give a positive antigen-antibody reaction, consequently the dilution step can just be shown positive in a diagnostic test. And because the dilution ration in chemistry corresponds to a different process, it must therefore be explained that it is correctly said to be an antibody dilution.

If a vaccine dilution is to be meaningful, then this must be at least 4 times the existing basic dilution. However, if there is an increase, then this indicates that a fresh infection is present, whereas, on the contrary, a decrease indicates that an infection has subsided. So it is also to be said that a single measurement of the whole therefore often has only a low significance.

An increase is necessarily linked to the presence of the respective tested antibodies, and since the production of antibodies only starts after approx. 10-16 days, an increase can also only be detected after 10-12 and more rarely after 14-16 days if an infection is suspected.

The bio-psychosocial factor, which finds its development in disturbances in those origins, which are founded in physical levels as well as in thought-feeling-psychic levels as well as in the social level, provides an explanatory approach to the whole, which I have to call now. On the physical level, these are, for example, reactions in the consciousness and brain that occur during substance use of the different levels. On the psychological level, for example, certain thought and emotional patterns such as a lack of self esteem, hatred, lying, slander, revenge, retaliation and deviousness, etc. can lead to substance use. On a social level, relationship groups also play a significant role, among others, such as groupings of peers that are important to the individual as a primary social reference group.

All levels influence each other and they are also decisive for finding the cause. Finally, the different factors contribute to a change in the consciousness and in the brain, through which messenger substances are released in the brain, which influence the entire body system with all its organs, as well as the consciousness. Also different strenuous and much strength demanding learning processes can cause a weakening of the immune system and thus participate in a virus infection. In this way, the changes in the consciousness and brain ultimately lead to the fact that the efforts create negative thoughts and feelings, which have a negative effect on the psyche and weaken the immune system. The

person who becomes dependent on these changes, however, does not perceive this, feels neither pleasure nor joy, but tiredness and falls into a bad mood, which has an overall negative and weakening effect on him.

In addition, certain situations in daily life can have an equally weakening effect on the immune system, such as the appearance and smell of people as well as certain foods and many substances. This leads to a conditioning resp. to forms of stimulus-stimulus-associations resp. stimulus-reaction-associations resp. to repetitive couplings of stimuli resp. linking of preconceptions, which create psychological restlessness and behaviors, which have a weakening effect on the immune system. This means that the situation itself triggers risk factors in the person, which play a negative role in the maintenance of the immune system and weaken it instead of strengthening it.

The susceptibility to what is explained differs from human to human due to different hereditary, environmental, developmental as well as ethical, character and moral factors. Ultimately, therefore, it is an interplay of different factors that can increase the risk of immune deficiency and thus of infection by a virus or protect against it.

Billy Excuse, everything what you say and explain, that has already taught me Sfath, to which however he also said that the whole of all earthly science greats, who would deal with the virology, epidemiology and immunology etc.. as well as especially by our earthlings-super-psychologists, who always want to know everything better and think themselves to be super-intelligent and to stand above the fellow human beings, because they are incapable in their narrow-mindedness to make even a tiny intellectual and reasonable thought in this direction. But speak calmly further, because I wanted to note this only incidentally.

Florena What you say, that also Ptaah has already told me, and besides I know much from his explanations, which he passes on to us from the records of Sfath, in order to inform us generally about it, which is to know about your personality for us just as importantly, as also about your abilities and everything learned.

But now I want to mention the rest of what Ptaah told me to explain: As far as the risk of suffering an immune deficiency and thereby more easily bringing about a viral infection is concerned, which will be denied by earthly virologists, etc. as Sfath already explained to you, as you say the most diverse individual factors of each person also play an important role in the whole thing, so also the environment in which the person lives, acts and acts, as well as his behavior, his life and learning characteristics, and even all substances with which he comes into contact in one way or another. Together, these can induce and increase the risk of immunodeficiency to such an extent that they can practically lead to a viral infection without any other susceptibilities. Therefore, different risk factors can occur, of which even virologists, epidemiologists, physicians and especially psychologists are not able to make any ideas, consequently they will deny everything, as for example hereditary, as well as purely individual factors of old, newer or present kind can be causally involved in infections, like:

1. depression;
2. lifetime substances taken in childhood or during life;
3. pressure to perform;
4. stress levels;
5. high pressure to perform and compete;
6. anxiety;
7. stressful personal life circumstances;

8. excessive demands of any kind;
 9. sleep disorders or pain conditions;
 10. mental disorders or illness;
 11. attention deficit;
 12. pressure to make decisions;
 13. hyperactivity;
 14. wrong social environment;
 15. bad acquaintances, friendships or family relationships;
 16. strenuous or unloved professional life or work;
 17. risk factors due to abuse of substances of any kind, etc.;
 18. interpersonal conflicts with parents, siblings, friends, acquaintances, strangers;
 19. poor academic performance;
 20. under achievement of skills;
 21. separation from a loved one;
 22. death of a loved one;
- Etc.

These are the explanations of Ptaah that you want me to tell you, to which I think I have mentioned everything and have not forgotten anything.

Billy Thank you, and if it wasn't complete you could always say it after the fact and elaborate. ...

Billy ... But just now something else comes to my mind concerning the Corona epidemic, and that is that Sfath said at that time that even then extreme caution should continue to be exercised, respiratory masks should be worn, and distance from fellow human beings should be kept when the epidemic recedes, because a subsiding of the epidemic wave is no guarantee either for its end or for greater safety. And I also remember from the time with Sfath that what will happen with the coming somewhat subsiding Corona epidemic is not simply the final end, which is why protective measures should continue to be observed by the sensible among the people. In part, the coming slowing down of the epidemic is due to the climatic conditions of spring and then the coming summer, as Sfath explained at the time. This means however that possibly with a further climatic influence the epidemic can rise again and new disaster can break loose. This however possibly also differently than by the plague itself, as by other sufferings and illnesses, which can arise from the plague by impulse releases or by transformation consequences, as Sfath explained. Possibly, however, also sufferings and diseases could arise, which develop insidiously from not recognizable virus infections. And further, the Corona epidemic causes in many people so I remember what Sfath explained at that time not only death, but also severe long-term health damage that cannot be cured. This is also the case with regard to insufficiently and negligently tested vaccines, as well as dangerous health complaints caused by the epidemic, such as heart failure and other vaccination effects, etc., which very often lead to death and cost many human lives, as is also the case with regard to various long-term brain diseases, which cause serious life long complaints or in many cases lead to death. Further I know from Sfath also that from the virologists, physicians and epidemiologists as well as health institutions and immunologists etc. much important information for the populations is concealed, like e.g. that the Corona virus proteins attack very strongly the signals of the immune system and manipulate this in such a way that it fails. Consequently, it is necessary as I have already learned from the teachings of Sfath to do everything necessary for the immune system in order to maintain its extremely vital total body-organic function, which is to be handled in particular reasonably by the human being consciously in such a way, as the immune system is supplied with additional strengthening vital substances if necessary. However, these do not correspond to more than effective vital substances, which can strengthen the immune system and

maintain it to a certain extent, nothing more, because as corona virus repellents or corona remedies they are not worth anything, because they do not correspond to remedies.
