Why is there graphene oxide in Covid vaccines, what else is in them and who is responsible?

Dr Robert Young spoke to Stew Peters EXCLUSIVELY, about his past and his findings after examining the vials from Pfizer, Moderna, J&J and AstraZeneca that contain the 'secret' contents of COVID- syringes that are called 'vaccines'. Microscopy expert Robert Young analysed vaccines from Pfizer, Moderna, AstraZeneca and Janssen and found chloride, sodium, but also graphene oxide. His investigations also revealed that the vials contained nanoparticles consisting of magnesium oxide and aluminium oxide.

"That's the most concerning thing. These are the most toxic," Dr Young said on the Stew Peters Show. He explained that other research has shown that such oxides are 'cytotoxic and genotoxic'. In other words, they damage the body's cells and DNA.

He also found parasites called trypanosomes in Pfizer's vaccine. "They may claim it's a contamination that occurred during production, but these types of parasites don't normally occur here."

He said he has also studied flu vaccines in the past and that oxides in nano form have been added to vaccines since 2016. "The Russians, Chinese and Americans have been researching this for some time," he said.

Who is behind it? Young quoted Bill Gates, who stated during a TED talk in 2010 that he believes the world's population could decline by 10 to 15 percent.

Seventy to eighty percent of the particles end up in the reproductive organs, Young said. "In the female, this leads to sterilization; in the male, it leads to decreased sperm quality."

Guest commentary The media agitation is getting out of hand



Isn't that Marco Rima with his hooked nose, hunchback and crazy-greedy look? A caricature that uses the stereotypical stylistic devices of anti-Semitic propaganda. It's the climax of a media smear campaign against the uninfected that has been escalating in recent weeks.

The caricature can be found in 'Blick' on 5 September 2021 in an article entitled 'These are the five types of vaccination refusers'. The Marco Rima type is presented as 'the freak' and given attributes such as 'völkisch den-kend', 'radicalised', 'hallucinogenic late effects', 'pathological' and 'rage citizen'.

What makes a newspaper like Blick give free rein to such hatred and further divide society? Probably the conviction to fight for the good and against the evil. This is precisely the conviction that propaganda in totalitarian systems thrives on - the more evil the enemy to be fought is, the easier it is to legitimise harsh means of combating it - and it's worrying that these means of propaganda are increasingly finding their way into many of Switzerland's leading media. That this does not come out of nowhere, but is the preliminary culmination of a development, can be reconstructed from the last few weeks. For a long time, the media have waited for incidents at the weekly demonstrations with which the enemy image of the violent government critics could be served. After the Zurich health director Natalie Rickli was doused with apple juice by a citizen who was obviously dissatisfied with her policies at the inauguration of a vaccination bus on 21 August, things were ready to start: The 'propensity to violence of vaccination sceptics and opponents of measures' is on the increase, claims 'Blick' on 26 August, citing as proof

the apple spritzer attack on Natalie Rickli'. Of course, part of the media's agitation is first and foremost the generalisation that draws conclusions about everyone from an individual case.

Federal Councillor Alain Berset gratefully accepts this sentiment and on 27 August allows himself to be accompanied into the arena by the anti-terrorist unit 'Scorpion' with media attention, where he faces critical questions from the population. Blick' spoke of a 'high-risk appearance in the SRF arena'. On 28 August, the Federal Intelligence Service (FIS) told the NZZaS that vaccination centres were realistic targets for a terrorist attack - referring to Islamists - and on 29 August '20min', in agreement with several other daily newspapers, ran the headline: "By vaccination opponents and Islamists: FIS considers attacks on vaccination centres likely". Although the NDB did not speak of vaccination opponents, '20min' even puts them ahead of Islamists in the headline. Reason? None.

Hubert Mooser asks, also on August 29 in 'weltwoche-daily': "Health Minister Berset lets himself be accompanied to the 'arena' by an anti-terror unit: Are opponents of vaccination already considered terrorists?" Various other media outlets have practically already answered this question in the affirmative on the same day. Mooser's conclusion: "How political opponents can be turned into violent extremists is something we've only seen in countries like Belarus, for example.

So when the media write about the unvaccinated, they are dealing with potential terrorists, with violent extremists. The editorial in the 'SonntagsZeitung' of 15 August can hardly be interpreted in any other way. Title: "Now Berset must finally force his opponents to vaccinate". More verbal violence is almost impossible. The

The unvaccinated are openly called 'opponents' who must be 'forced'. By what means, then? Author Denis von Burg writes: "The Federal Council and the cantons must now put all possible pressure on those who refuse vaccination. The taboo of compulsory vaccination, be it direct or even indirect, must fall now." In an open letter on September 1, Michael Bubendorf, media spokesman for the 'Friends of the Constitution', asks, "Mr. von Burg, what does 'all possible pressure' mean?" How far is Denis von Burg willing to go? Where does the conceivable end and the unthinkable begin? The online newspaper 'nau' refers to demonstrations announced on 27 August in Brig and Schaffhausen as 'Corona riots'. Wikipedia defines an insurrection as follows: "An insurrection, sometimes also called a popular uprising, rebellion or insurrection, is in the narrow sense an open, violent resistance of several people against a state authority. This means, on a case-by-case basis, an armed act of resistance against an existing government; the preliminary form of an insurrection is often street battles in centres of government and population".

What is the word of the Federal Council worth? "... even if vaccination uptake remains low"

The Swiss population was promised the start of the normalisation phase under certain conditions. These conditions have been fulfilled. But now the opposite is happening. What value does the word of the national government have? Stefan Millius on 8 September 2021

One can and should get upset about the unrestrainedly oversized federal administration financed by the taxpayer. We often do, too. However, it has one advantage: What is once decided and said is documented somewhere. Officially, irrevocably.

We remember the three-phase model of the Federal Council, once meaningfully introduced. We all stared at the last point: the normalization phase. That's when life is supposed to go back to the way it was before. Whether this life was 'normal' or not is another question, but still: business as ususal.

When exactly should this normalization period have occurred? Let's take the federal government at its word:

"Once all adults willing to be vaccinated have been fully vaccinated, the normalisation phase begins. (...) The remaining measures (access and capacity restrictions) are to be gradually lifted. This strategy should also be maintained if, contrary to expectations, the population's willingness to be vaccinated remains low".

A clear word. A verifiable one. Today, September 8, 2021, one can soberly conclude: Anyone who felt like getting vaccinated up to this point could do so. And how high the corresponding quota is should not matter. At least if you believe the Federal Council.

What is happening instead? We are facing an expansion of social discrimination. The argument for this is allegedly overcrowded intensive care units. That is a topic in itself, we have dealt with it here. But more importantly, where exactly is the 'normalisation phase' linked to intensive care units? The Federal Council has clearly stated that access and capacity restrictions are dependent on all adults willing to be vaccinated being fully vaccinated. Period. From.

Only that doesn't apply anymore. Just like that. In front of running cameras, the current infection rate, combined with the very questionable utilization rate of intensive care units, was elevated to the new decisive criterion.

Who defined this? Who decided it? Why can a three-phase plan, originally set in stone, suddenly be so watered down? Why can new criteria be invented when the old ones do not give what one would like?

We shouldn't expect an answer to that. But as a reminder, before the Federal Council strikes a major blow, it once defined something completely different as a strategy. He is ignoring his own criteria. It is making what it has decided itself into a waste paper.

Everyone who wants to is vaccinated. The normalization phase should now occur. You don't even have to discuss it. That's just the way it is. Many people in Switzerland who have their certainties delivered to their living rooms by Swiss television or any other media that is friendly to the state are probably of the opinion that the Covid 19 certificate is a good thing and rightly punishes those who still haven't grasped what the hour has come to. Since Corona, suddenly that doesn't count. With masks and certificates, it's now "Your body belongs to the community." Where is the protest of the feminists, the progressives, the liberals?

"You have been warned!": Unvaccinated Australians to be jailed

Australians who have not been vaccinated against COVID-19 will remain locked up indefinitely, while those who have been vaccinated will have some of their freedoms restored, Prime Minister Gladys Berejiklian told unvaccinated Australians: "You've been warned!"

The announcement was made at the same press conference where Dr. Kerry Chant revealed that COVID contact tracing was part of the 'New World Order'.

New South Wales state officials unveiled a plan to gradually lift the region's brutal lockdown, calling it a 'roadmap to freedom' that doesn't include people who don't get vaccinated.

Once 70 per cent of Australian adults are vaccinated, up to five people are allowed to meet in their homes, only if everyone is fully vaccinated (wow).

Up to 20 people can gather outside, and some domestic travel will be allowed.

Unvaccinated people, however, continue to be kept under lock and key and are forever second-class citizens, as Berejiklian lectured them like little children.

"Living with COVID means a cautious and gradual reopening once high vaccination rates are achieved in the adult population," Berejiklian said.

"We have of course consulted the national plan and also sought advice from our health experts and stakeholders to ensure that the resumption of vaccination at 70 per cent of the double dose is done in a safe manner and is only for vaccinated persons," she added.

"So you've been warned! If you are not vaccinated, get vaccinated or you will not be able to participate in the many freedoms that people with 70 percent vaccination coverage have," Berejiklian said. Those who are fully vaccinated must continue to wear masks, and Berejiklian said the most draconian restrictions could be reinstated at any time.

"Those who have received the double dose have a free hand, but if there is a rush or unexpected events occur, the government will give advice that people in certain areas or cities will have to restrict their movement so that they are not all over the country," she said.

The two-class society will of course be enforced via vaccination cards, which will exclude the unvaccinated from any social life and eventually also from general shopping, if the communist Chinese social credit is introduced in the Western countries.

In public comments, doctors and medical professionals 'crucify' COVID vaccines

Nearly 2,000 comments - and growing - on the Medscape page asking about medi- cine concerns about COVID vaccines show that a significant number of physicians are not as supportive of the vaccines as lay people might think. From doctors calling the vaccine a 'poison called graphene oxide' to others saying "there is more than a preponderance of evidence to justify immediately halting the administration of the vaccine," experts had registered 1782 comments by 9 a.m. Tuesday, Sept. 7, 2021, with hundreds questioning the vaccines or reporting personal experiences of adverse effects from them.

One doctor said the vaccine was 'intentionally dangerous, disabling and deadly'. Another said she refused to even call them 'vaccines' because "as most people and health care providers now know, vaccines are not sterilizing and do not confer immunity, so the regulations and pressure to vaccinate every human arm on the planet don't make sense to me."

"At any other time in my career when a vaccine has had so many problems (RSV, H1N1, dengue, HIV, rotavirus, deadly measles, and several others), vaccines have been withdrawn," said another doctor. "Considering that more than 99% of people who get COVID survive, the current situation of forcing vaccinations with products that have side effects that can end careers or lives is more than troubling."

Dominique De Silva, 30, is still seeking answers from doctors after developing a long list of debilitating conditions after her first dose of Pfizer's COVID vaccine, including severe neurological complications, pain and being unable to walk at times.

In an interview with 'The Defender', Dominique, who introduces herself on Instagram as @QueenCityDom, said she was moving from Las Vegas to North Carolina to start a new life, get married and open her real estate practice when she decided to get vaccinated. Having only one living parent, she wanted to protect her mother and other loved ones. "This virus took such a toll on me that I wiped down my food with Clorox wipes, covered myself everywhere, stayed away from my friends, used hand sanitizer 24/7, and lived in complete fear of getting sick," Dominique wrote in an update on her Go Fund Me. "When I had the opportunity to get vaccinated, of course I took it as soon as I could because I wanted my life to go back to the way it was before."

On March 18 - two days before her big move - she and her now-husband received their first and only dose of Pfizer's vaccine.

Shortly after, Dominique felt the typical fatigue she had been warned about before the vaccine, but she also noticed changes in her vision. "I think I just dismissed it because maybe it was just iro- nical," she said. "It felt like everything was super bright and too much to handle."

Dominique said she felt terrible, but thought maybe she was tired because she was preparing to move across the country. "I felt like my brain was sick," she said. "That's the best way I can describe it because I've never felt like that before."

The next day, Dominique got on the tram to the airport and said it felt like an elephant was sitting on her chest. "I didn't know what was happening to my heart, but it didn't feel good," she said. "Before I got on the plane, I started getting the first signs of a migraine and saw spots in my field of vision, but the migraine never really came."

Within two weeks of receiving Pfizer's vaccine, Dominique noticed cramping pain in her legs that felt like growing pains late in the evening. The next morning, the leg pain returned.

Dominique said, "I got up and had to hold onto the wall because my legs were giving out and the pain was coming back. So I walked around my bed to the bathroom and it took a really long time to get from A to B. I was so tired. My legs were weak and numb, and I was having trouble walking. At that moment, I realized that the vaccine had done something to me."

The pain didn't go away, and after seven days Dominique decided she couldn't wait for her new insurance to kick in before seeing a doctor.

"My husband took me to the hospital that same evening where I was admitted," she said. "I informed the doctor that I had been vaccinated two weeks and three days ago, but he waved it off and said that what I was experiencing was absolutely not related to the vaccine."

After a full MRI scan of the brain and spine, as well as numerous blood tests, the neurologist on duty could not find the cause of Dominique's symptoms. Although some conditions were ruled out, her symptoms were not treated or resolved and she was asked to see a neurologist.

After months of waiting for appointments with three different neurologists, she began to experience numerous other symptoms, including vertigo, insomnia, leg pain, shooting pains, dull aches, weakness, difficulty walking, brain fog, short-term memory loss, visual disturbances, anxiety attacks, sensory disturbances throughout the body, out-of-body sensations, depth perception problems, internal vibrations, tremors of the right hand, tinnitus in the right ear, muscle twitching, deep pain in the brain stem, tics, vocalizations, and involuntary eye movements.

The first neurologist Dominique saw was very open to the possibility that the vaccine could be the cause, she said. "He said he's seen some weird things related to vaccines, but he wasn't sure what to do about it," Dominique explained. Next, Dominique sought out a traditional neurologist. "As soon as he heard me say that I had been vaccinated two weeks before the onset of symptoms, it seemed like he canceled the appointment," she said. The neurologist looked at Dominique's MRI and said there was nothing to see here and she needed to see a therapist. "We go to these people that we trust, that have told us to get these shots, but if there's something wrong with us, we're told it's in our head," she said.

Dominique then went to a functional neurologist who listened to her loud and clear, she said. The neurologist told her, "This is definitely something that the vaccine has triggered in you."

The doctor explained to Dominique that she was experiencing dystonic storms and recommended glutathione, turmeric and other supplements to treat her dystonic movements and inflammation.

According to the 'Journal of Clinical Movement Disorders', a dystonic storm is a distressing hyperki- netic movement disorder. Clinical features of a dystonic storm include fever, tachycardia, ta- chypnea or changes in breathing, hypertension, sweating, and autonomic instability. Dystonia may be tonic (i.e., sustained posturing) or phasic (i.e., irregular twitching). Pain is common and often requires aggressive symptomatic control.

Dominique changed her insurance and had a specialist examine and diagnose her at a renowned hospital, but it would take another four months.

Her symptoms became so bad that she went to the emergency room to be treated more quickly. There she waited 22 hours until a 'seizure' occurred and the staff finally performed a CT scan to rule out a stroke.

"The results of the CT scan were clear," Dominique said. "The doctor started slapping me in the face, pinching me to make the seizure stop, and recommended anti-seizure medication."

Dominique said the doctor did not recognize the adverse reaction and said there was no test to confirm it was caused by the vaccine even if it was. However, a physician's assistant and a nurse practitioner recognized that it was a vaccine injury.

At the hospital, Dominique also underwent a D-dimer test to look for blood clots. The result was positive, but she was not taken seriously, she says.

Dominique then went to a movement specialist who also couldn't figure out what was wrong with her and recommended she see a therapist.

"She looked at the MRI from April, the CT scans, the EEG and the office exam," Dominique said. "She came back and said, 'You're not going to like what I have to say, but I think this is psychosomatic and you should see a therapist."

"Why is another doctor telling me I'm imagining things?" Dominique said, "It's not in my head." Dominique contacted two functional neurologists and a doctor in New York who performed blood tests and extensive testing that had not been done before. Dominique's PET MRI, EMG- nerve exam, nerve conduction test, and skin biopsy all yielded abnormal results.

Dominique was diagnosed with postural orthostatic tachycardia syndrome (POTS), a condition she did not have prior to vaccination, and autoimmune chronic demyelinating polyradiculoneuropathy

- a rare type of autoimmune disease in which the body attacks the fatty sheaths of fibers that insulate and protect nerves.

She also had neuropathy and brain scan abnormalities.

I saw your patient in neurological consultation today. This rear-year-old woman former real estate broker was well except for HT in remission, bloating with wheat, and a head injury in 2016, and sinus issues, until she received the first Pfizer COVID vaccination on March 18, 2021 without prior exposure to SARS-CoV-2. This was followed first by an immediate sense of visual changes and heightened sensation that have persisted. She developed a tremor of the right hand several weeks later, and 2 months later in June 2021 she noted forceful involuntary turning of the head to the left associated with vocal tics, rightward deviation of the eyes, and vocal utterances and stuttering speech that have also continued. She notes difficulty walking and pain in the legs. She has had head pressure and vertigo. She notes dizziness and palpitations and brain fog.

Examination showed distal weakness, sensory loss, hyporeflexia, Romberg sign, tandem imbalance, right hand action tremor, and gaze impersistence.

EMG and NCS of the legs and left arm dated 8/10/2021 showed moderately severe distal acquired autoimmune chronic demyelinating polyradiculoneuropathy.

Left calf and thigh epidermal nerve fiber analysis dated 8/10/2021 and forwarded to were pending.

Autonomic studies dated 8/10/2021 showed symptomatic orthostatic intolerance with hypotension and reflex tachycardia with HUT.

The findings were consistent with moderately severe distal acquired autoimmune chronic demyelinating polyradiculoneuropathy, painful small fiber polyneuropathy, dysautonomia and CNS disturbances manifesting tics, dystonia, and tremor in the setting of prior Pfizer COVID vaccination, gluten sensitivity, HT and remote head injury.

Dominique said her doctor in New York believed in vaccines but she had 'obviously had a bad reaction'. Dominique sent her results to the neurologist at the prestigious institute, who said her symptoms were 'all in her head'.

Dominique was not previously exposed to COVID and suffered from autoimmune Hashimoto's thyro- ditis, although she has been in remission since 2019. She is currently undergoing further testing to determine the extent of her injuries.

CDC and Pfizer ignore vaccine injuries

Dominique contacted a local member of Congress about her vaccine injury, who told her to contact VAERS, the CDC, and the manufacturer - none of whom followed up.

Dominique filed a report with the Vaccine Adverse Event Reporting System (VAERS) and contacted the Centers for Disease Control and Prevention (CDC) about her vaccine injuries. She also contacted Pfizer, which sent her a questionnaire, which she returned by mail.

She also reached out to Sen. Ron Johnson (R-Wis.), who has been a vocal advocate for government transparency and has acknowledged others who have been harmed by COVID vaccines.

Dominique mustered up the courage to share her story on Instagram and it went viral, but she was also harassed, bullied, received hate messages and death threats. She said she has since met many people who have the same issues and are forced to do their own tests and pay for their injuries.

Dominique has set up a Go Fund Me page to raise money for her medical expenses, since there is no financial assistance for people harmed by vaccines outside of the Countermeasures Injury Compensation Program, which almost never provides compensation.

Dominique has spent thousands of dollars on lab tests, scans, her PET MRI, skin biopsies, hospital visits - which go into collections - and radiology bills, which she posted on her Instagram and Go Fund Me page.

"I'm not here to tell you to do or not do anything with your own body," Dominique said.

"Do your own research and make your own decision. I was not given this information and I did not have the opportunity. The people who are hurting and suffering every day and have no jobs need help."

Dominique no longer drives a car and has put her real estate practice on hold. She's not sure she'll ever go back to it. She got married and said it was a 'good day' for her symptoms, but she had to figure out how to make room for a wheelchair.

On her Go Fund Me page, Dominique said:

"I will never regret why I got vaccinated because I did what I thought was right for myself and for everyone around me. I had the best intentions when I rolled up my sleeve and got my first dose. I knew there wasn't much data on these very new vaccines, but I trusted the science behind them. Unfortunately, my body reacted terribly to it and put me in the situation I am in today.

Although Dominique said she believes in freedom of choice, neither she nor her husband will receive any more doses of a COVID vaccine. ""It happens to a lot of people, they just don't want me to talk about it," she said.

According to the most recent data from VAERS, a total of 14,485 cases of dystonia, dystonic tremor, neurodegenerative disorders, neurological symptoms, neuropathy, polyneuropathy, and tremor were reported following COVID vaccination.

Doug Casey on the real reason the mainstream media is stoking fear

International Man: The mainstream media can turn up the fear in society much like you turn up a thermostat in your own house. And right now they seem to be cranking up the fear to hysterical levels. Governments are able to take radical measures when people are scared. How do you assess the situation and the role of the media?

Doug Casey: The great American journalist H.L. Menken once said, "The whole object of practical politics is to terrify the populace (and then gloriously keep them safe) by threatening them with an endless series of hobgoblins, all imaginary."

He was right

Fear is one of the most powerful and primal emotions, and government has always used fear to unite people behind it. The government - which produces nothing - exists only because of fear. Fear of foreigners is mitigated by their army. Fear of chaos in its own country is mitigated by its police.

The media is an ideal tool to spread fear. The media have become the government's lapdog. They all have the same talking points and convey the 'narrative' in the same way. Of course, the government and the media have always worked hand in hand, but now more than ever. There are no longer thousands of independent newspapers scattered across the country, but only a few con-glomerates that control all the major print and electronic media.

One thing that hasn't changed about media is the old adage, "If it bleeds, it leads." Fear, danger and violence make stories interesting and exciting. They make events urgent - and most importantly, they make people buy newspapers and visit their websites.

I don't trust the government - which pursues its own interests and imposes them by coercion - or the media, which, if they know what's good for them, will either toe the party line or act like a 'loyal opposition' to give readers the impression they actually have a real choice.

This is a dishonest and disgusting farce...

International Man: CNN, FOX News, MSNBC, the NY Times, the Washington Post, and others are notorious for sensationalizing stories, dramatizing situations, and propagating certain themes. How is the mainstream media of today different from the mainstream media of decades past?

Doug Casey: They're very similar in essence, because the newspaper industry wants to sell newspapers, and television and radio want the public to hear advertising. The magazine industry wants to sell magazines. The more you sell, the more advertising dollars you get. This leads to a tendency to unashamedly copy off each other. That's why you have to be skeptical and critical and demand proof for everything.

In the 19th and early 20th centuries, there was the tabloid press. Hearst and Pulitzer were famous for stoking public enthusiasm for war. Everybody wanted to hear news from the front. There is absolutely nothing better - not even close - than a war to attract readers, listeners and viewers.

The mainstream media hasn't changed much in this regard. Newspapers and media have always competed with each other with outrageous headlines. If they're wrong, you forget about them and move on. If they're right, you don't let them out of your sight.

People like things that are interesting. That hasn't changed much, even if it's more about advertising than subscriptions these days. This is especially true with the ongoing COVID-19 hysteria. Big pharma has a lot of money to spend on advertising, and you don't want to make your major advertisers unhappy.

But there are other significant differences between the media of today and that of the past. First, the people who used to become reporters didn't have a college education. They were basically street kids who liked to write; they were much closer to the grassroots. They actually had to go out on the street to get the story. Today's reporters all went to college to learn journalism, as opposed to the 'school of hard knocks'. They get most of their information from the computer, not first hand like it used to be. Today they just google something and accept what someone else says as fact.

Another big difference is that Washington D.C. has grown exponentially in importance over the last 100 years; there is much more coverage of the D.C. government than in the past.

Reporters used to cover things they knew, their local scene. Today, unless a reporter works in D.C., he's almost irrelevant; all he knows is what other people are saying on the Internet. In general, the quality of reporting has declined tremendously over the years.

International Man: Is there still real journalism today? Where can you find it?

Doug Casey: The so-called 'flagship paper' in the US is the 'New York Times'. I used to read the NY Times, but not anymore; it's completely dumbed down. It should not be trusted. I don't even trust its science section anymore.

Everything has become very politicized. They try to link everything to global warming, COVID, or what the government should do to solve a real or - usually - imaginary problem. Everything is written through this filter. They even try to link scientific issues to critical race theo- ry and gender.

I want to see what people are reading, so I read book reviews. But in the 'New York Times', the 'New York Review of Books' and the 'London Review of Books' - I still subscribe to them out of inertia - it seems that most books today are written and/or reviewed by People of Color (POCs), people with sexual deviance or women. And they all seem to be left-wing drilled.

The left - the etatists and collectivists - have completely taken control of the mass media, especially the upscale mass media like The Atlantic, The New Yorker, and the publications just mentioned. They are just the vehicles that the elite use to talk to each other about being an elite.

If you want to subscribe to something today, I recommend subscribing to blogs, of which there are thousands on the inter- net. Pick blogs you think are reliable and subscribe to selected newsletters. Since it's your subscription dollars at stake - and not the favor of advertisers - they usually strive for intellectual honesty, even though, at least in finance, many have become nothing more than overpriced advertising rags. Be selective.

However, there are still some magazines that I think are good, like 'Reason Magazine' and 'The Spectator', but the selection is slim.

International Man: Big tech companies like Facebook, Twitter and Google are the new gatekeepers of information. In this sense, are these companies becoming the new mainstream media? What are the effects?

Doug Casey: Frankly, these big tech companies are past their prime. They are too big to be managed efficiently. They're arrogant and corrupt. And I suspect that most people don't like or trust them anymore, even though everyone uses them.

There will either be a technological change or a change in public sentiment that will turn them into dinosaurs. I am not interested in owning their extremely expensive stock, and not just because I despise them and their editorial contributions; they are stooges of the state.

The fact is that the government still cannot exercise direct censorship. It's too difficult because the First Amendment, at least in name, still exists. But as I said, these media companies work hand in hand with the state. Big government prefers to work with big tech companies like Facebook, Google, Microsoft and the others. There is no law prohibiting Big Tech from censoring anyone - and there shouldn't be, because they are a private company. They certainly don't want to give the government any more power.

This kind of 'private' censorship is a clever way to circumvent the Constitution. The fact is that these companies have become unofficial branches of the government - that's part of what the Deep State is all about. The good news is that this will eventually cut their own throats. They will become obsolete due to technological change and public sentiment. Many people - myself included - are already refusing to support them.

People who seriously rely on their news are basically useless, misinformed idiots. Thinking people look for their news elsewhere.

International Man: How can the average person find out the truth about a particular subject?

Doug Casey: First of all, you need to actively form habits of critical thinking. Ask yourself about everything you read or hear, no matter what the source: does it make sense? What's the hidden agenda? What is being left out? What is being distorted, twisted and given a 'spin'?

This is a very important skill. Subject everything to a process of critical thinking. Question everything - especially authority.

Number two: Trust your own eyes, ears and senses. I don't mean what you see on TV or read in Google. It is about things you see yourself 'out there'. Talk to people face to face to find out what the man on the street is thinking, not what some reporter claims he is thinking. Or maybe I should say what he feels, because few in the public think. Try being your own personal reporter. Get out there and explore the real world firsthand. Don't just accept what any reporter tells you.
