## **Long-term effects of Corona**

### **Excerpt from the 766th contact of Saturday, February 20, 2021**

**Billy ...** As I know from Ptaah, because I asked him (talking to Onkoton) 4 years ago to clarify it, how it stands between man and woman regarding domestic violence, consequently clarifications were made by you the Plejaren, which resulted in Europe alone 28% of the women are beaten, thrashed, abused and raped by their 'spouses' and even murdered quite often. So that was 4 years ago, to which today, however, there is probably a lot more to it, I think ...

**Ptaah** That is indeed so, as I know, because we recently carried out new observations in this regard, but you can not know because I did not tell you. Today's number, in Europe alone, as a result of the Corona plague and the consequences of house arrest, has unfortunately increased in the populations to 36.2 percent.

**Billy ...** You can also explain what Sfath and I have determined about 70 years ago, that at the Corona time the true lousy personality and character of many rulers and politicians will prove as well as their belief in God as well as in salvation in connection with charity, honesty, honor, dignity and morality, when they will make secretly dirty business with means of protection against the epidemic to the detriment of the populations and at the expense of their lacking financial means and will enrich themselves by it. This will also be done by everyday criminals, including companies and corporations, who will exploit the stupidity of the government at the expense of the taxpayers, who, due to their inability to think and govern, believe that companies, individual businesses and corporations, etc. must be supported with state money. This is precisely because the governments, in their stupidity, do not know what really needs to be done, and as a result, with their billions spent on criminals, they will fuel the fraud system and drive it to unimagined heights.

But what we could now briefly discuss, without mentioning the whole theater of the Corona epidemic as well as the stupidity of those directors and the troublemakers of the populations - through whose fault many deaths are to be mourned - are these questions here, since someone asks why all responsible scientists cannot find out how the late effects from the Corona epidemic come about, which arise after the surviving of the epidemic with a certain part of the 'recovered'. Also here in this fax it is asked, why then the scientists, who are considered as predestined of the medicine etc., do not find the reason for appearing late effects and why they could say nothing about it, how these would be and how long they would last etc.. Also here, there is asked what and how it is about information concerning the mutations etc., because it would be important that the people would be enlightened about it, what however neither by those self-important as well as stupidly talking government morons around the world - so it really is here, as you can read ... just as nothing would do, in order to enlighten the population, as also the majority of the virologists etc. as also the medical profession not. And since you are trained in your numerous learned occupations as a physician, chemist, medical doctor and virologist etc., so I think that it would be very well appropriate if you would explain once the necessary, because our earthling 'experts' and governing are obviously incapable of it, but on television, radio and in newspapers and journals etc. only a big mouth can lead and make themselves important. And if you give explanations, which I hope you will ....

**Ptaah** Yes, I will explain some things. ...

**Billy** What the woman also asks, that refers to how long the Corona viruses would survive on objects etc., if you would like to say something about that, then that would really be something for you. Concerning the 'survival' of viruses I still have to mention that the woman also asked me about it by telephone, consequently I explained to her that on the one hand viruses of every kind are no life forms, what she did not understand, however. Therefore I had to explain everything to her better.

...

First I explained that viruses are not life forms, but just organic structures and consequently do not die and can only be dissolved and destroyed. The woman already did not understand this, because she thought that 'organic' means something like life, because all living beings have organs. Unfortunately, I am not a scholar and also not a scientist in this respect, therefore I could only explain what I learned from Sfath in the 1940s and also learned something more myself, namely, that organic structures just do not correspond to anything else than a natural product of organic chemistry. And this says, so I explained to her, that the 'organic' of the structure must not be understood as life, but as a chemical element, consequently the whole is not a living being, but only a structure. But the woman did not understand this either, namely what a structure is, consequently I explained that a structure corresponds to an orderly assembling, composition, a construction resp. a certain order, so in the mentioned case just in chemistry, but as it is also valid for everything else, like for a consistency of thoughts, a work, action or speech etc.. I then explained that the whole basically also includes any compounds of carbon with other elements, of which - as I still know from the instruction of Sfath from the 1940s - more than 30 million are known among you Plejaren in this respect. To the whole however, so I remember, and I told the woman also, Sfath said at that time, also all life building elements belong, whereby the carbon for all life on our earth holds the absolutely decisive meaning and is absolutely indispensable for all living beings. If I remember correctly, what I explained to the woman also in such a way, the carbon is integrated indispensably into a global cycle of organic and inorganic compounds, whereby it reaches among other things also from the air into plants and into all living beings at all, which use all up to the tiniest organisms the carbon for the energy production, because basically down to the tiniest life form all have an organic carbon cycle which guarantees only or at all alone the life and life ability.

If the forms of carbon on earth are examined, then many millions of different organic compounds can be found, which, as I already said, are indispensable for the functioning of all living organisms, as they are also of important importance after their death in the carbon cycle. Basically I explained to the woman what I still know about organic structures, which exist as lifeless organic molecules, simply as various natural elements, such as halogens, with which she of course could not begin anything, after which I tried to explain that these somehow originate from a chemical element, from a yellowish green gas, which has a pungent odor, from which salts and in detail fluorine and thus bromine, iodine and chlorine as well as, among others, a rare radioactive element are formed. Among other things also a rare radioactive element, whose designation I did not know however any longer and which did not come also up to this day into my senses. What I also explained was that halogens are strongly reactive non-metals, as well as that the basis for the diversity of the single molecules with respect to carbon is often hydrogen, sulfur, nitrogen and oxygen, which form the actual chemical structure and the functional groups. What I remembered from Sfath was what I then knew to say, that there are millions of forms of organic compounds in all sizes, whereby these organic carbon compounds have an extremely extensive variety, much more numerous than all compounds together which have no carbon. Altogether they form for all living organisms, thus also for humans and all life forms at all the nonplusultra life building element. Also they store the energy, furthermore all information, which is inherited and which is stored in death with the passing away process altogether into the Environment and are taken up and stored by this as a whole. And with it I was then at the end with my Latin. ...

But then now it would be your turn, my friend, to answer the question of the life span of the corona virus when it is deposited on objects etc..

**Ptaah** We have talked about this before, and since then, according to our research findings, nothing has changed. But still, I can mention again the information given at that time: On hard and smooth objects, corona viruses can remain active for up to 48 or 52 hours before they decay and dissolve. In the maximum case, they can remain active for up to 96 hours if they fall on suitable surfaces. If they are able to embed themselves in a host material that is suitable for them, they can remain active for centuries and millennia, only to break out again in the distant future due to some circumstances.

**Billy** Beautiful prospects.

**Ptaah** This will not be able to be changed for all times to come. What the woman writes and asks in this letter has its justification, to which I think I can also give a concise answer to everything, like to this question here concerning pets, to which I can explain that we Pleiarens do not keep animals, beasts or any other living creatures in our direct living area. If such forms of life are kept, which, however, according to our directives, cannot be the case in areas of cities and villages due to hygienic and health reasons for the inhabitants, but only in settlements, as you once called them, where, depending on the genus or species, they can live in special enclosures offering enough space, or also in the open, where they can live similar to nature or nature like. Small cages and enclosures that do not provide the genera and species with freedom-like space to move are not allowed under the directive.

**Billy** So if you are talking about domestic animals, then we can compare that on earth with dogs and cats, rats, birds and various other creatures, which, however, as a rule - except for cats and dogs that can go outdoors - are kept in living rooms etc. in far too small cages and become mentally ill, which of course is not recognized by the keepers of these creatures. This is because they have no knowledge whatsoever regarding the psyche of the creatures - such as birds, hamsters, lizards and creepers, etc. - that they keep in their homes in cages, breeding cages or enclosures that are far too small. What will probably have to be explained with regard to the settlements, as I have called them, they are individual plots of land which, according to earthly measure, are 100 x 100 meters and thus about one hectare in size. True, this is not exact, for it is a few meters more according to your Plejaren measure, but on the whole it can be assumed to be one Hectare can be assumed, whereby on this area at least one dwelling house stands, in which only one family is resident and from which the country with field, meadow and garden is also cultivated. At least that's what I saw and also received explained.

**Ptaah** Also what you have often said is correct and corresponds to the effective indisputable facts concerning the state leaders and the experts of the medicine and virology etc.. You explained to me already at the beginning of the epidemic what you and my father Sfath had learned in the 1940s about how, that this Corona virus has special peculiarities, before we ourselves had even an inkling of it and only by our researches came to the same results as you told me and knew from my father Sfath from the 1940s and 1950s. On the one hand these were your explanations concerning the late effects, on the other hand concerning the impulse depositions which lead to different kinds of late effects. Only by your information we were stimulated to carry out corresponding researches, which in the course of time confirmed what you explained. ... You, Eduard, dear friend, know about the whole thing, therefore I only want to take it up a little bit, although you have already explained it some time ago and it can also be read on your web page, in order to deal with these questions here in a short way, which I actually should not do. Since these people who are raising these questions have obviously not read all of our conversations that you have retrieved and written down on your website, I want to briefly answer some things with respect to these various questions.

Concerning the late effects that occur after recovery from the Corona plague, first of all it should be understood that, according to our research findings, an effective **and complete recovery from this strange man-made plague is absolutely impossible**, but only corresponds to a sham recovery. This is because the corona virus exists not only as such, but unusually also as an indestructible impulse unit or as a basic physical quantity, which as an impulse object shows peculiar characteristic states of motion. This impulse object contains within itself a closed system of a constant organic-energetic impulse set of different factors, and these correspond to pure triggers in relation to disturbances, which affect the normal physical and psychic block of the whole human organism, whereby the efficiency and the well-being of the human being are subjectively and objectively perceptibly negatively influenced and inevitably illnesses occur, which can be of different nature depending on the case.

The corona plague impulses depositing in the whole organism of the human being arise inevitably with every human being and remain after a recovery lifelong, however, as a rule, for a long time inactive, whereby then, however, for medically inexplicable causes unexpectedly a suffering or a serious illness can become acute. Then the causes of the sufferings and illnesses, which appear on the one hand even after 30, 40, 50 or more years unexpectedly, cannot be found out by the earthly physicians and scientists, because on the one hand the impulse deposits in the organism cannot be recognized with the given and still primitive earthly-medical as well as earthly-medical-technical possibilities and also cannot be investigated yet, as consequently the whole of long-term resulting late consequences also cannot be met medically averting. According to our research findings, there are several kinds of late effects: on the one hand, the stored impulses cause suffering and diseases only after decades, while on the other hand, late effects can occur already after days, weeks or a few months after recovery. A further late consequence arises in the way, if already during the course of the corona plague sufferings and illnesses develop, which continue to exist after the recovery and are long lasting or, like all consequences of corona sufferings, can last for many months, years or lifelong. Our very detailed Earth-wide observations and records conducted over the past 26 months - since the Corona disease was detected in January 2020, unnoticed by Earthly virologists and physicians, has steadily mutated as the 5002nd mutation since its first appearance in mid-1977. Mutation since its first appearance in the middle of the 1970s in November 2019 acutely and in December in Wuhan as Corona plague recognized and began to spread world-wide -, show that 27% of all those suffering from the epidemic and those who have recovered from the epidemic suffer more or less from various slight losses of well-being as a result of the stored corona impulses lifelong. 19% will be sporadically affected by the stored energetic corona impulses for the rest of their lives by recurring light to medium illnesses and diseases. This, while 12% of the corona-affected have to complain at present already before and after the recovery of striking heavy sufferings and illnesses which can last many months, years and even lifelong and can lead to the bad tribulation and an agony as well as to sickness and to infirmity. If the whole of the Corona plague is further analyzed, then it can be seen that the facts of the Corona virus as a virus created by humans further show that it is not stable and consequently subject to permanent and more dangerous mutations, as it can also contrary to earthly-medical, virological and epidemiological false claims jump to children and animal life forms.

In addition to the dangerous mutations of the Corona virus, there are also numerous smaller joining mutations that produce various side effects, **such as these have been instrumental in producing 5002 different mutations from the virus since the mid-1970s**, according to our findings up to January 2020. These mutations can either cause a change in the virus structure or change its behavior. and change the genetic code and shape, and when they occur, they can become more aggressive and dangerous than those from which they mutated, hence most new mutations become more lethal.

**Billy** If I may interrupt you, dear friend, because I would like to say to it also still something, namely what I have already noted with our 764th conversation report on 26 January, namely this what I have copied out to bring it up again, because I have found neither on the television nor on the radio or in any

newspapers etc. an information about it. It may be that neither our virologists nor the medical profession or doctors etc. have found anything in this regard so far, but it may also be that everything is kept quiet and the populations are deliberately not enlightened, as is the case with many things. So if I may recite this excerpt:

*"...Well, there are various other things, as also that e.g. the new corona mutations have the property to infect a person not only with one mutation alone, but that one can be infected by their 2 or under circumstances even their 3, as also that a person infected by the one mutation and <cured> can also be infected again by another corona mutation and fall ill. This has already been stated by Sfath, but whether this is already known to today's virologists and physicians, I have not yet heard anything about it, because up to now nothing has been reported on television in this respect, just as no such message has been heard on the radio and, to my knowledge, nothing has been written in newspapers either. If the whole wrong acting of the governments, their incapacity for the fact and situation evaluation as well as the complete absence of the inevitably necessary foresight, as on the other hand also the missing intellect and the irresponsible acting of that part of the population is considered, which crosses and crosses despite the half-value orders given by the governments - even if the issued government orders are really only halfway correct and useful - then it is quite clearly already pre-programmed with it that the whole disaster will continue for a long time and will claim further many death victims."*

That, Ptaah, I simply wanted to have mentioned again, because so far no information has appeared in any public organs. But you can continue with your explanations now, please.

**Ptaah** It may certainly be good that you brought up the information again. But what I have to explain further is this: In recent months, several new wild mutations have emerged from the original virus discovered in Wuhan, such as I mentioned earlier as joining mutations, which have been discovered not only by us but also by various terrestrial virologists. These mutations show minor or major changes, which not only show changes in terms of contagiousness, but also cause different effects in case of infection. Depending on the geographical areas, especially in different climatic regions, such changes develop that in quick succession new mutations resp. virus variants emerge, which furthermore usually become more malignant and aggressive, resulting in new waves of infection, which dissolve the previous ups and downs of infection waves and fatalities and consequently a new spreading of the epidemic begins, but this with a new virus mutation.

What we have been able to observe since the first onset of the Corona epidemic in January 2019 in southern China and then from November 2019 in Wuhan, and since then have also repeatedly observed, has remained the same to this day, namely that on the one hand comparable mutations occur simultaneously in various locations in different areas, and on the other hand the various new virus mutations also develop the property of docking more easily, more quickly and more effectively with a suitable host, infecting it and also impairing its immune system to such an extent that it succumbs to the virus attack.

Another unfortunate consequence of the corona epidemic, according to our research, is the fact that if antibodies are formed as a result of infection with a corona virus, they cannot guarantee complete protection against the virus.

Thus, antibodies do not provide absolute safety and protect only partially or not at all against further infections, either by the old virus or by a new virus mutation. According to our research, antibodies can neutralize various corona viruses only partially or not at all, just as vaccinations can be useless, just as recovery from a corona virus disease cannot guarantee immunity. In this regard, our findings show beyond doubt that despite antibodies and vaccinations, new infections are also possible with the mutating virus. What has now been explained, Eduard, are the facts that I want to state openly, but not further explanations.

**Billy** That is enough, I think. Besides, further disclosures would not be good; on the one hand, they would probably incriminate in research details that we laymen would not understand anyway.
