**How the Corona pandemic will develop**  
**Extract from the 749th contact report of Wednesday, August 5, 2020**

**Billy** Speaking of overpopulation, I can see that the more it increases, the more unemployment increases, but this is not recognized by statisticians and so on, and therefore not calculated. The fact is that with the insane growth of the mass of mankind, the growth of technology also goes along with it, and this in such a way that the more and more robotizing automation technology expands in such a way that more and more automated and, so to speak, independent robotic machines carry out the necessary work, and this always x times faster and faster than humans could do with machines that they themselves would have to monitor and operate. Thus it results with the time that more and more robot automat machines androidengleich all possible work carry out, besides many times faster than humans, follow that these become completely redundant for work achievements, which leads then to catastrophic consequences. If the overpopulation continues to grow unchecked, murder, riots, hatred and enmity, envy of bread, manslaughter, violence, crime and civil terror, as well as family violence, family crimes, disorder, the domination of the rich over the workers and their exploitation, as well as destructive forms with regard to all forms of order, will become more and more prevalent, and consequently all kinds of manifestations and proliferations will become an ugly daily disorder. Already today, as a result of the Corona crisis, such forms of aberrations are appearing here and there, as is shown and demonstrated by the fact that parts of the population are rebelling against all the precautions taken by the governments and authorities and are not abiding by the necessary decrees and rules, causing millions of infected people and thousands of deaths. And this is probably only the beginning of what will happen over time, even without a corona epidemic, if the overpopulation is not reduced by a worldwide birth stop and a comprehensive birth control. And this will happen, that is pre-programmed, because if the earthlings step each other more and more on the feet, their freedom of movement more and more restricted and the indifference around the personal and the fellow men well-being more and more egalitarian becomes, as this already more and more arises, then everything runs to to whom indifference is irresponsibly shown, and this is already proving to be true today. This is already the result of the fact that large parts of the population are already indifferently and irresponsibly disregarding the corona precautions and the very protection rules recommended or prescribed by governments and authorities as a precaution against corona disease. They travel abroad on airplanes, private vehicles or public transport, organize small and large amusement parties and binge drinking, visit brothels, cinemas, bars, inns and theaters, as well as participate in public music shows, swinging and gymnastics festivals and other sports events that violate all health security, such as stupid football tournaments, etc. Bathing on river and sea beaches or in public bathing establishments, which are teeming with indifferent and irresponsible earthlings, are sources of infection and death by the Corona virus, as well as any demonstrations and other mass gatherings of any kind.

A certain majority of all rulers and earthlings are completely irresponsible and indifferent to the Corona Plague, with the result that an enormous number of unstable earthlings are also seduced by irresponsibly indifferent or Corona Plague liars and by crazy conspiracy theorists etc. to rebel against, violate and disobey any protection and rules regarding the Plague. This, however, is fatal for many of them when they become infected or even pay for their indifference, ignorance and irresponsibility with their lives. But it is also the majority of those in power who shamefully fail and are incapable of

drawing up all the necessary security measures against the corona virus and of making the necessary regulations for the populations, as well as of ensuring that these are respected, with police and other security forces controlling and enforcing the whole thing. Persons who disregard the security measures that have been enacted should be singled out and punished with drastic penalties, such as heavy fines or, in repeated cases, longer prison sentences.

**Ptaah** We didn't want to talk about the Corona disease anymore, but now that you have brought up this topic, I would like to say a few things about the coming course and the consequences of the disease. What you have just mentioned will unfortunately have serious consequences, because now the Corona epidemic pandemic is really spreading and is reaching its peak, which will only be reached in a few weeks and will claim millions of infected people and many deaths. It must also be said, however, that all the figures known to date regarding those infected and killed by the corona epidemic do not correspond to the facts. On the one hand, the epidemic was already spread from China in January/February 2019 to various countries, but not yet mutated in the way that the further mutated virus did in Wuhan in November. At the end of January 2019, many people around the world were infected by the virus and many died from the disease. However, this was not recognized worldwide, because the treating physicians always diagnosed different and wrong diseases and reasons for death. This changed only when the further mutated epidemic appeared in Wuhan and spread from there in the new variation worldwide. However, this virus continues to go through mutation phases, which from time to time cause new susceptibilities to disease, but this is usually not recognized by the entire terrestrial medical science and thus also by the virologists, because they do not have the necessary knowledge in this regard, nor do they have all the necessary technical, apparatus and chemical as well as other requirements.

As we have again researched for the next few weeks ahead, the official infections alone, which will increase in the next few weeks, will reach 27 million by the end of this month of August, while in a few weeks the death toll will exceed one million. However, this only concerns the official cases, as these will be publicly announced by then, while the number of unreported cases of all infected persons and deaths worldwide is much higher.

The fact that the number of infected and dead as a result of the Corona epidemic will now increase dramatically worldwide in the coming weeks is based on exactly the facts as you just mentioned. And this is quite obviously so, because all the reasonable explanations and advice that are given are not taken up in the memory, understood and therefore neither taken seriously nor obeyed by numerous incorrigible people. What is explained corresponds to the way you say in each case, "It is the most stupid of all the stupid who bring disaster in the world. But you also say, "It is heard that there is talk, but the stupid do not hear what is said and explained, so that they will understand nothing, remain stupid, and perish. How correct your statement in this regard is will now be proved, on the one hand, by the fact that now the still rolling 1st Corona epidemic wave is approaching its climax, and on the other hand, because neither the leaders nor the populations are realizing the precarious Corona epidemic situation and consequently are not taking the protective measures that would be inevitably necessary. On the other hand, unthinking and consequently stupid and absurd false claims and declarations are being spread that the 2nd wave of the epidemic is already raging, although it is still the 1st wave that is now approaching its peak and is all around erratically demanding large masses of infections and deaths, which will be unstoppable worldwide in the coming weeks. On the one hand, the entire spread of the epidemic is due to the inability of the leaders and authorities, as well as the WHO and the official health organizations, to assess the effectively precarious situation and to determine and implement the necessary measures. On the other hand, if I may quote your words, it is the masses of the people themselves, who are totally incapable of reason and reason, who in their stupidity do everything

possible to make the evil even worse. And this is done in various ways, such as denying and spreading simple conspiracy theories that the Corona disease does not exist or that it corresponds to a state repression of basic rights. Exactly these basic rights are taken up more and more by those who are insane in terms of reason and reason, as we have explored by looking into the future, from which terror-like revolts of the population result in a demonstrative way, as these have already taken place several times, but will increase in the future and become a danger against the security of the people and every order. As we noted with an eye to the future, there will be new revolts and demonstrations in the near future, fired up and stirred up by criminal enemies of state and order as well as corona liars and elements of conspiracy which will bring with them bloody violence, as there has been before. These demonstrations will be caused by incitements of anti-state and anti-order elements, which will gather many of the mindless, stupid, irrational as well as ignorant people from the population to live out their hostility to the state and order. Some of the extreme right-wing and extreme left-wing groups are also behind these machinations, as are certain politicians, as we have seen, who take revenge in this way because they are unable to put forward or enforce their confused views, ideas, conceptions and desires in their circles.

If everything is analyzed exactly, then it is to be recognized in particular that now the Corona epidemic is able to rage primarily due to unreasonableness and stupidity as well as the irresponsibility of the state leaders their high point toward its height. This is because the people's leaders have shifted the responsibility away from themselves and consequently, instead of enforcing all necessary protective measures against the corona virus, they have dissolved the lockdown. They have, for the most part, irresponsibly ended the obligation to comply with all necessary and important protective regulations and have left all actions to that part of the stupid, ignorant and intelligent weak of the population that lives in a clueless and unpredictable indifference and is not aware of any responsibility, and this corresponds to the factor by which the Corona epidemic can rampantly reach its peak, which now claims many victims.

All in all it can be seen - if I may continue to speak in your always accurate manner of expression - that through all the wrong, irresponsible, ominous and partly very childishly ridiculous speeches, pseudo-knowledge, pseudo-statements, decisions, In this way, the grossness and inadequate conduct of the leaders and that section of the population which is ignorant and incapable of reason and reason, all evil and misfortune in every way, up to destruction, annihilation and rampant death, can spread inexorably throughout the world.

Those responsible for the Corona pandemic have trivialized it by calling it <COVID-19>, which is an understatement and trivialization of the precariousness of the disease and its insidiousness. This is because, from a purely psychological point of view, both the majority of innocent leaders and the population are misled by this banal designation and for themselves play down or even completely question the profound danger of the disease. This proves that the state authorities, virologists, epidemiologists, psychologists, medical doctors, etc., have little or no knowledge and experience of psychology, as well as of the necessary psychological behavior and naming of any facts. Consequently, they are not able to understand, as they are not able to understand in any way, that their misnamed corona disease pandemic is simply called <COVID-19>, which minimizes the danger of the corona virus for all virologically and medically uneducated people. That they want to stick to protection rules, however, only becomes apparent when they themselves are infected by the disease, although it can often be too late and the last path must be taken, as you once said.

But what needs to be mentioned now is the following, which I am explaining because I feel obliged to do so, for all FIGU members and all worldwide to our declarations etc. I feel obliged to repeat a few

things for all those interested and to show how precarious the situation of the Corona epidemic really is. So I think that it will be necessary to supplement everything that has already been presented earlier, which should also be brought into the internet.

1. It is inevitable to publicly denounce the failure of the state leaders and their responsible persons and their incapacity and to call upon them to finally work out proper protective measures with regard to the corona epidemic and to implement them in their entirety. All of them have failed due to their incompetence and wrong assessment of the situation. Above all, this also concerns the WHO and the <United Nations World Health Organization>, as well as the majority of the governments of all countries. As a result, no or only inadequate necessary measures have been taken, which means that all those responsible, especially those in power, are incapable and culpable of acting wrongly and neglecting all that is necessary, thus not counteracting the current pandemic, but rather promoting it.

**2. It should be especially mentioned that if in Europe only Italy and Spain were affected by the corona epidemic in a degenerate way and otherwise in all European countries there were much less corona infected and corona deaths in comparison to other countries, which is now changing radically, then this was due to the fact that the majority of the populations were placed in the lockdown and thus protected themselves from the epidemic. But the irrationality of the leaders, who relaxed the lockdown far too early and even ended it, appealed to the self-responsibility of the people, who were, however, overburdened with it and, as a result of the action of anti-state and anti-order elements, incited hatred among the people, which led to quarrels, mainly concerning an alleged deprivation of liberty, as well as especially concerning an alleged restriction of fundamental rights and the like, which led to demonstrations that from now on will continue in an evil way and will provoke violence that will eventually take on bloody and terrorist forms.**

**It is now a fact that the corona epidemic is now claiming its victims throughout Europe and that in the near future the corona epidemic will increase the number of infected and fatalities.**

3. Apparently, the virologists and physicians etc. have still not penetrated what I made clear months ago in the beginning of our explanations, namely that there is no effective immunity of the convalescents as well as no herd immunity even if <healings> from the corona disease take place and antibodies have formed.

4. Even after a <healing> or completed recovery, there is no immunity to the corona virus, therefore after a successful <healing> a new infection by the corona virus can occur at any time and can be fatally dangerous, as well as infecting further, as the disease continues to exist in the body as impulses and cannot be detected even by virological and medical specialists.

5. The fact that the corona disease is now spreading in Europe after the temporary containment through protective measures is due to the fact that the ECDC and the European Commission have been responsible for the spread of the disease. <European Disease> Control Agency, the WHO and all relevant governmental authorities as well as the health organizations of the countries, which due to their incapacity and loudness are still not able to assess the still rampant and precarious epidemic-dangerous situation, therefore they do not make public very necessary information and do not work out the protective measures against the corona epidemic etc. in order to have them implemented.

6. However, with regard to the implementation and execution of all necessary disease control measures, the responsible authorities of all governments of all states are obviously not able, nor sufficiently far-sighted and foresighted, to adopt and implement the necessary protective measures for the population.

This is fundamental because they are not at all able to assess facts correctly, and consequently they are not able to make the right decisions effectively, because they are absolutely incapable of doing so and for their office, and are totally incompetent, untalented, unsuitable and unqualified.

7. The danger and lethality of this insidious corona disease is due to the constant mutation of the virus, whereby the resulting mutation changes bring about new genetic variations that become more dangerous and aggressive, which cannot be recognized by doctors, virologists, etc. because they do not have the necessary knowledge and tools.

8. The changing dangerousness of the corona virus and new gene variations also lead to new susceptibility to infection, which from now on will affect younger people and young people up to the youngest age of children, as has been explained earlier, even the fruit of pregnant mothers will be affected, who may suffer life-long health damage from the corona virus.

9. The previously mentioned factor that all genera and species of mammalian organisms, especially domestic animals such as dogs and cats, cattle, horses and pigs as well as rodents etc. are susceptible to the corona virus and that humans are infected by it (contrary to stupid claims of alleged <specialists>), has still not penetrated the virologists and physicians, so they still deny this fact.

10. Spread of the disease can occur seconds after the moment of infection and not, as is claimed, when the infection becomes detectable.

11) Repeating earlier declarations is still done today to explain the following with certainty: Wearing protective masks against pathogens such as bacteria, fungi and parasites only makes sense if the masks are suitable and are used sensibly, but this cannot be the case if they are worn during the day on the open and pedestrian-free street, in open terrain or in buildings where there are no crowds of people in close or narrow areas.

In principle, masks available in the public domain are only useful if they are thick and dense enough to prevent the exhalation of breath, aerosols or expiratory droplets, as well as the inhalation of similar substances from outside or from other people, which should not be absorbed or inhaled.

Even good ordinary face masks of quality FFP1, which are usually triple-layered and fleece-coated, offer no benefit and protection against viruses, because they usually only have a protective function against bacteria, fungi, parasites, dust, sand and pollen and the like. Better functional and special filter masks are those of quality and grade FFP2, but even these do not protect against viruses. In contrast, special medical masks of FFP3 quality only provide limited protection, but only between 94-96 percent safety. Therefore, protective masks should on the one hand be equipped for a specific purpose, and on the other hand only be used if it makes effective sense and is necessary. But if this does not correspond to a necessity and a protective mask is still worn, then this is not only nonsensical but also ridiculous and is tantamount to a carnival fuss, as I explained earlier.

**On March 2 I literally explained the following, which remains valid and should be observed:**

1. **Firstly:** When speaking, the air in the mouth and through the nose is expelled as very fine droplets, i.e. expiratory droplets or aerosols. During this process, the breathing air from the mouth and nose becomes visible, but only on cold days, not on warm days. This expulsion, however, has the characteristic that this breath-droplet-puff usually expands to about half a meter when it is cold and is then inhaled by speakers standing close to the person speaking, which leads to breath-droplet-puff infections.

2. **Secondly:** On cold days, the breath expelled from the mouth condenses, and so the breath-droplet-puff or expiration-droplet-puff becomes visible and appears in the air like small wafts of mist from mouth and nose.

3. **Thirdly:** Condensing breath-droplet breath is not only produced by humans, but also by animals and certain creatures.

4 **Fourthly:** During the process of the breath-droplet breath, which as explained can only be seen on cold days, not on warm days, it must be noted that this breath is also expelled from the mouth at warm times when speaking and is subsequently inhaled by close persons.

5. **Fifthly:** The breath-droplet-breath of the human being, which must be mentioned again, becomes always then visible, if the humid-warm breath of air from mouth and nose meets cold and damp outside air. The reason for this is based on a physical property of air, because it can only absorb a certain amount of water vapor and make it visible. Warm air also absorbs water, and more so than cold air, whereby this warm air ejected from the mouth, in contrast to the cold, spreads further and invisibly in the warmth, up to about two (2) meters, but depending on the wind conditions, further, which corresponds approximately to the extreme limit of exhalation.

6. **Sixth:** The breath-droplet breath of a human being also has a weight, and at zero degrees, the weight per person and per cubic meter is about 4.5 - 4.8 grams, whereas at 30 degrees it is about 30 grams. The breath-droplet breath, however, also saturates the air, which means that, depending on the humidity of the air, it can only absorb a limited amount of moisture from the expiratory droplets.

7. **Seventh:** When the breath-droplet-breath cools down more and more, the breath-water-vapor changes in such a way that tiny breath-water droplets are formed, which then float in the air and spread out.

8. **Eighth:** The breath that becomes visible through the cold as a breath-droplet-breath is dependent on the ambient temperature on the one hand, but on the other hand also on the humidity of the air. Breath droplet breath that becomes visible can only be produced and made visible from a lower temperature, and only when the water vapor molecules contained in the expelled breath condense so quickly that they immediately crystallize as tiny mists.

9. **Ninth:** Infection contact can also occur through coughing and sneezing of the infected persons or dogs and cats, because pets can also be carriers of the corona virus. Direct contact or smear infection with the viruses on objects, body surfaces, food or other objects on which infectious expiratory droplets have been deposited also leads to contamination if they subsequently enter the body via the mucous membranes, e.g. in the mouth, nose or possibly via the eyes. Transmission via the faeco-oral route and other bodily excretions can also occur, as well as via infected animals, creatures and domestic beetles such as cockroaches, etc.

These are the most important and necessary facts, Eduard, which I have to mention again, and with this I have explained everything, I think, which had to be further explained again.
