RV/Boat Dealers: All indoor space is \$1.00 per square foot and sold in numbered spaces; all outdoor parking for units is \$.25 per square foot. All dealers will be provided with 110V electrical outlets. Any phone lines or banners hung need to be ordered through the Abernathy Agency no later than January 31, 2018; add \$125 per phone line and \$50 per banners hung. A deposit of 50% of total entry is due upon receipt of registration; remaining balance is due no later than January 1, 2018.

If you need pipe, drape, tables, chairs, carpet, etc., please contact the Abernathy Agency.

The load-in for all RV/Boat Dealers in all buildings will be February 8th, 2018 from 8:00am to as late as you need to be there.

Exhibitors: All exhibitor spaces are indoors sold in 10'x10' booths for \$200 each and include one 110V electrical outlet, pipe & drape for sides and backdrop, sign with business name, one 8' draped table and 2 folding chairs per 10'x10' booth.

The load-in for all exhibitors is February 8th, 2018 from 12p-10p and February 9th, 2018 from 8a-10a. If you need to drive into the building to set up your booth you will need to contact the Abernathy Agency no later than February 1, 2018, to make arrangements. If you need carpet, extra tables, extra chairs, etc., you will need to order them upon receipt of your registration and add to your total entry fee.
