Purpose: EQ-i 2.0/EQ 360 Certification

Confidentiality

Your results (test protocol and reports) are viewed only by those responsible for their preparation and for delivery of feedback to you. All information is regarded as confidential. Following your feedback session all copies of your reports are destroyed. Your results are maintained in Multi-Health System's database, strictly on an anonymous basis, for use in any future research that would involve the EQ-i 2.0. All information shared with your feedback professional is confidential and subject to rules regarding privileged communication between a qualified professional and a client. If any aspect of your results is discussed with others who are not directly involved in the provision of feedback, such as for consultations or teaching purposes, no identifying information is disclosed.

Exceptions to Confidentiality

There are five situations in which reporting are compulsory by law:

1. Suspicious of child abuse,
2. Indication of intent to commit suicide or physically harm others,
3. Indication of previous or present sexual abuse by any other Regulated Health Professional,
4. Subpoena by the court, and
5. Fraudulent use of government-issued identification.
