An evaluation is made on puppies at 8 weeks, Males will have two testicles descended into the scrotum at maturity or a replacement will be made when one becomes available (replacement is the only option).

This animal is warranted against fatal genetic defects for 1 year from the date of purchase. The new owner has 48 hours from the date of shipping to have the Pomeranian examined by a veterinarian of their own choice, at their own expense. This animal is warranted against fatal defects for 1 year from the date of purchase. Should this puppy be determined to be suffering from a fatal defect deemed to be hereditary (within 1 year from the date of purchase), Force's Pomeranians will replace the puppy with one of the same value when one is available after notification and written verification has been furnished to the breeder by TWO independent veterinarians. The breeder will not be responsible for any veterinary costs at any time.
