## **Discussion:**

1. Kyle called the meeting to order @ 8:00 AM

- 2. Minutes from the January 9, 2018 Board Meeting were approved.
- 3. Treasurer Report:
  - 1. Jeff handed out the Reconciliation Reports which were approved and attached to these minutes.
  - 2. The proposed budget for FYE 1/31/2019 as submitted by Jeff was discussed. The Board approved the proposed budget to include a few changes discussed at this meeting. Jeff will make the changes per Board discussion and send the budget to Tracey to be included with the information that will be sent out to Owners ahead of the Annual Meeting in March.

## 4. Marina Manager Report:

- 1. The whaler replacement work on G Dock has been completed by Stillwater. Stillwater will come back later this year to complete the repair on the roof supports on G dock.
- 2. Tom installed one water meter on A dock to test water usage for a water lift per proposal submitted by Jeff Felix during the January 9, 2018 meeting. Tom will ask Jeff Felix to submit a draft agreement to the Board between the slip Owner with water lift and NYBA that states:

The Owner of the slip shall be responsible for any and all damage and/or cost including the water meter, meter maintenance, and all water usage associated with connecting the marina water supply to the water lift.

- 3. Tom got an extension from the City for the permit for G dock.
- 4. Tom will contact Evan Wehr, ECCO design to ask about permitting on D & E docks.

### 5. Issues for Discussion:

- 1. The Board discussed email correspondence from Trevor Campbell and Alan Bohling to NYBA concerning paying for access fees for slips G-44, G-45, G-46 and G-47. Kyle will contact Steve Kitz to ask him to research the easement for ingress, egress, utilities and construction over G dock for the owner of property west of G dock including these four slips. The easement was signed by Radovich and Keys in 1979. Steve Kitz will also look into ownership of the NW end of C dock aka C-95.
- 2. Kyle will also ask Steve Kits to research ownership of the property and bulkhead east and west of E dock.
- 3. The Board did not make any changes to the information package to be sent out to Owners ahead of the Annual Meeting in March. Jeff will contact our insurance representative and Clack Nuber to request representation at the meeting.
