1. Kyle called the meeting to order @ 8:00 AM

- 2. Minutes from the May 24, 2018 Board Meeting were approved.
- 3. Treasurer Report:
  - 1. Jeff handed out the Reconciliation Reports which were approved and attached to these minutes.

2. Jeff will open a money market account with Vanguard and move approximately \$190,000 (Reserve Account) to the new account.

# 4. Marina Manager Report:

- 1. Tom didn't have an update about meeting with a Stillwater representative and the engineer to talk about design and construction estimates for D dock bulkhead. Tom will call Stillwater.
- 2. SBC has brought in a street sweeper to clean up the rubber residue left by their forklift.

#### 5. Issues for Discussion:

- Sid and Terry talked about getting the Owners to vote and attend the Annual Meeting. We
  need more participation. The Board agreed and we will begin with a request in the next
  eblast for Owners to vote and attend the Annual Meeting.
