Good morning:

I have sent this several times to the Village of Bawlf, via the CAO Tracey Ormsbee, but it has bounced back with the message that Tracey is not in the office.

It is important that this item be on the agenda for the next Council meeting for the Village of Bawlf. The Villages Representative position on the CDSS board has been vacant for over half a year. Earlier this month, Alison Barker-Jevne volunteer to serve. Alison is a resident of Bittern Lake – see her short bio in my original email, below.

Two people have contacted CDSS expressing an interest in serving on the CDSS board. I've provided both with background information and spoken with both. One has decided to step back for now, knowing that another person is also interested. (The reasons for the decision to step back are all good ones, and we had a lovely chat.)

So we may soon be in a position to welcome Alison Barker-Jevne to the CDSS board. As you know, Village Councils each approve the appointment of the Villages Representative. I hope this can be on an Agenda for either the February meeting or, if you've already met this month, the March meeting.

Alison lives in the Village of Bittern Lake. She is retired from a long position with PDD – Persons with Developmental Delays, which is a provincial program through AB Community and Social Services (formerly AB Human Services. Alison is familiar with CDSS, though more so when PDD was active in community partnerships and Wendy Gregg was the Executive Director of CDSS. She is quite flexible with her schedule, as she has 14 hours week of respite care from her now 'full-time commitment' caring for her elderly mother who lives with her and her husband. She moved to Camrose in 1986 (same year I moved!), and onto an acreage in Bittern Lake 21 years ago. She and her husband Cliff owned Four Seasons Bottled Water until 2014. Cliff continues to be involved in small businesses. Alison's education focuses on PDD and Rehabilitation related training, with diplomas/degree/certificates from Mount Royal College, Grant MacEwan, Athabasca U and the University of Calgary. She has lots of interests and, while she hasn't mentioned board experience, she definitely has experience in community engagement and the human services sector.
