- BWIF reserves the right to suspend or terminate with immediate effect and without compensation membership to the film guild for any breaches of these terms and conditions and/or harmful irreconcilable differences or lack of interest.
- Moral Clause: Member agrees to maintain social websites that are not offensive to the organization, such as nudity, violence and profanity, sexual behaviors on their media outlets.
- BWIF reserves the right to use, distribute and advertise product(s), photos, etc. created under the terms of BWIF without penalties.

- Members request for the team's participation must be put in writing at least 30-60 days in advance to assure Team's availability.
