- BWIF members are in no way form or fashion is allowed to join any female filmmakers' groups or organization. This is considered to be a conflict of interest.

- BWIF members will be removed from the website 30-60 days after departure.
- If you choose to resign, please be aware that we will continue to use footage and photos for advertising according to our release form.
- Certain information about members will be collected and held by BWIF as part of the enrollment process and may be requested from time to time from members. We agree not to share or sell this

information with anyone outside the Film Guild. However, we reserve the right to publish the name of any member on BWIF on its sites.

- We take no responsibility for any information posted by any member of BWIF closed Group Facebook site or any other media source.
- BWIF members will be held accountable with any negative behavior, gossiping, bad habits or actions that discredits the organization or disrespect team members.
- It is the member's obligation to inform us of any changes to the member's enrollment information. Members warrant that the information they provide is true and correct.
- Neither BWIF nor affiliated businesses nor any of our members or legal entities make any warranty or representation nor take any responsibility or liability as to the quality or suitability of any prizes, awards any service, reward, prize offer or benefit from any third party.
- Membership upgrades will require a six-month waiting period after submitting request to upgrade membership for administrative changes to process.
- Members are NOT allowed to broadcast, duplicate, discuss or barter information spoken in confidence amongst BWIF members, at anytime, anywhere.
- Members are encouraged to take advantage of classes and workshops offered by BWIF "Platinum" Leaders.
- Platinum members are expected to instruct workshops to students without payment as a part of our Give-Back program. However, if services are rendered members are allowed to charge for services outside of BWIF volunteer hours.
- BWIF member are not allowed to request advanced services within 60 days probation period. These services are film production services and film editing up to four hours volunteer service.
- Only [active members] are allowed to request assistance on any of their project(s) at least (4) or more volunteer hours from team.
- We require that every member volunteer for their required (4) hours or more on any project before requesting the team's participation.
- Members have the right to deny volunteering on certain movie sets due to their belief and/or morals.

- Members are only allowed to work on one major project a year for member, so choose wisely. Project must be submitted six months prior to event or film shoot.
- Members request for the team must be put in writing 30-60 days in advance to assure Team's availability.
- Members are require to pay monthly dues of \$20 by the 20th of each month following the month after joining to brilliantwomeninfilm@gmail.com. This will renew your membership each month.
- If membership dues is not receive in two consecutive months without communication, member will then receive a notice of termination after a warning.
- Monthly dues are collected to provide funding for events, administrative duties and supplies, deposits, advertising, gas stipends. Wherever and whenever the funds are needed, we will always notify the team.
- If member for whatever reason leaves the group, with or without email notification, they will not be allowed back into the organization for an entire year but are allowed to attend programs at full cost.
