Art Requirements

- All work **MUST** be created by you the applicant/artist; mass produced, commercial & resale items are not allowed
- All work must be attractively displayed in a professional manner
- All work must be consistent with images represented in your application

GSR reserves the right to request anyone not following these guidelines to leave the show.

General Information

- Artists are responsible for collecting & paying Minnesota Sales Tax (7.875%)
- We provide breakfast snacks in the morning and a lunchtime meal. This courtesy only extends to 2 artists/helpers per booth. Additional amenities can be purchased if necessary.

High Resolution Image Requirements

- 300 dpi or higher
- 3 x 5 inches or larger
- PDF, TIFF or JPG files preferred
- October 1st high resolution image deadline is very firm.
