The Board met on March 27th at the pool house. We did not have any neighbors provide comments during community time. We look forward to our neighbors coming out to the meeting on the 24th of April.

You may have seen the Landscape Committee out planting in the Fall on the hill between Ridge Hollow and Willowick. (pictures are available on the Facebook Page) This is the beginning of the community erosion plan. As the weather begins to warm, they will be out planting additional plantings on that hill. They are also outlining the next areas to focus on in the erosion plan. #### **Dumping in the Community**

Over the past several years, there has been a steady increase in residents putting out materials that Trash Away will not take or require special pickup/payment by the resident. There have been appliances, paints, construction materials and other large items left out with an assumption that they will just be taken away. Some of these items have been hazardous like full fences with exposed nails and large appliances that could trap or crush a child playing around them. Dumping on non trash days has also become an issue. The community as a whole continues to be left to pay for the removal of all these items carelessly discarded as an added expense. We need your help. If you see someone violating the trash guidelines please report it to East Coast Management immediately. Without your assistance the board may be forced to consider imposing special assessments above and beyond ordinary HOA dues to offset the continuing costs incurred to remove these materials from the property. The obvious preference here for everyone is for those responsible to pay for removal, not the community.

Here are the items Trash Away will not pick up:

The following materials require special handling and or disposal and special arrangements must be made;

Hazardous Waste: acids, ammunition, antifreeze, asbestos, car batteries, caustics, chemicals, dead animals, explosives, fire extinguishers, fluorescent bulbs, herbicides/pesticides, motor oil, wet paint, poisons, propane/helium tanks.

Electronic Waste should be taken to a certified e-Waste recycler. For assistance locating one, visit Trash Away's recycling information page.

Construction Debris: concrete, brick, block, palettes, tile, drywall, etc.

Large Landscaping Projects: mulch, dirt, rock, stumps, and sod.

Medical Waste: Used needles and syringes may be sealed in a thick, impenetrable plastic bottle (such as a laundry detergent bottle). The sealed bottle can then be discarded in your regular household trash -- the container is no longer recyclable.

Unused prescription medications should not be placed in your trash or recycling container and should never be flushed down the toilet. Contact your local pharmacy or visit the DEA Office of Diversion Control for drug take-back programs. Note: The DEA National Prescription Drug Take Back Day is scheduled for Saturday, April 28, 10 a.m. - 2 p.m. Unused or expired prescription medicines may be dropped off at all Fairfax County Police Stations on Take Back Day.

# Read these Most Commonly Made Mistakes

Get AECC approval BEFORE YOU DO ANYTHING TO YOUR EXTE-RIOR: Review current guidelines on our website or contact ECM if you have questions. A site inspection letter will be mailed for any violations. You are held responsible for compliance to that letter.

Help keep our NEIGHBORHOOD CLEAN: by picking up litter, your dog's waste, and keeping toys and other objects properly stored. Bring in your trash containers asap after pick-up.

CHECK YOUR PARKING PASS: Make sure it is a valid one and is facing out when hanging from the rearview mirror. If you lose your pass you must pay \$400 for a new one.

Review Timbers RULES AND GUIDELINES FOR TRASH: Place your trash in front of your homes between 6:00 PM Sundays and Wednesdays and 6:00 AM on Mondays and Thursdays. Recycled trash is only picked up Thursday mornings. Large trash is on Thursday but you must call Trash Away at 703-339-4560 for large item pick-ups.

Trash can be a lure for wild animals, ensure you have it properly contained when left out overnight.
