Warranty



Mystic Motorized Screens are engineered to be of the highest quality and to meet the demands of a worldwide market. The manufacturer, Advanced Screenworks, LLC. warranties that the Mystic Screen to be free of defect when it leaves our facility.

This manufacturer's warranty is granted, solely, to the original final purchaser and covers components as specified herein below.

Electric motors are warrantied for a period of twenty years from the original purchase date. The warranty covers the cost of the replacement electric motor. It does not cover the cost of labor, shipping, transportation, removal or any other service cost. The defective motor must be returned to the manufacturer at owner's expense. The new motor will be sent to the owner upon receipt of the defective motor.

Remote Controls are warrantied for a period of two years from the original purchase date. The warranty covers the cost of the replacement remote. It does not cover the cost of labor, shipping, transportation, removal or any other service cost. The defective remote must be returned to the manufacturer at owner's expense. The new remote will be sent to the owner upon receipt of the defective remote.

Painted Aluminum Components are warrantied for a period of two years from the original purchase date. The warranty covers the cost of the replacement aluminum component and is limited to manufacturer's defect. It does not cover damage caused by normal wear and tear or misuse. It does not cover the cost of labor, shipping, transportation, removal or any other service. The defective painted component must be pictorially documented and approved by manufacturer.

Screen Fabrics are not warrantied other than for manufacturers defects that would be evident at time of installation.

Mystic Screens are designed to provide natural ventilation and certain protection from airborne insects and other pests. Windy conditions may affect the performance of the screen. Mystic Screens should be retracted into the canister (a) in windy conditions, (b) during inclement weather, (c) when not being used, especially for prolonged periods of time and (d) other similar circumstances. Mystic Screens are not intended for storm protection of any manner and should not be used as such.

Except as otherwise specifically set forth herein, manufacturer makes no representation or warranty, expressed or implied, statutory or otherwise. All implied warranties, including those of merchantability or fitness for use are hereby disclaimed. In particular manufacturer makes no warranty the product will comply with pertinent national, state and local health and safety laws, including but not limited to U.S. Federal Occupational Safety and Health Act and the regulations, rules and orders issued pursuant to any such laws.
