

Dog Training Waiver and Release

I,, hereby acknowledge that I am voluntarily participating in dog training (including but not limited to group classes, private lessons, boarding and walking, collectively, "Training" with Veterans Canine Intelligence Academy ("VETSCIA"), a 501(C)(3) organization		
1.	I understand that Training may involve risks to myself, members of my family, third parties or my dog. I hereby accept and assume, without reservation, all risks associated with my participation in Training including, but not limited to, the risks of any and all injuries to myself, my dog, my family members or third parties who may participate in Training.	
2.	I understand that there is always some unavoidable risk involved when working with dogs, and in the unlikely event, that may cause injury or death. I believe that every effort will be made to ensure the safety of me and my dog, however in the unlikely event me and/or my dog(s) is injured, whether by another dog(s) or another cause, I assume all risks associated with participating in this Training. I AGREE TO FULLY INDEMNIFY, RELEASE AND HOLD HARMLESS VETSCIA AND ITS OWNERS, CONSULTANTS, TRAINERS, PRINCIPALS, AGENTS, REPRESENTATIVES, AND THE PROPERTY OWNER WHERE TRAINING IS HELD, FROM ANY AND ALL LIABILITY AND CLAIMS OF ANY NATURE INCLUDING BUT WITHOUT LIMITATION ALL COSTS, LOSSES AND LEGAL EXPENSES INCURRED OR ANY OTHER CLAIMS, INCLUDING ORDINARY NEGLIGENCE, IN THE EVENT OF INJURY TO MYSELF, FAMILY MEMBERS, THIRD PARTIES OR MY DOG(S).	
3.	I agree to assume all responsibility for any damage done to property, persons, or other dogs done by me or my dog's actions. I understand that if my dog(s) is the cause of property damage, I shall solely be legally and financially responsible for all costs related to the damage. I understand that if my dog(s) is the cause of injury or death to another animal or person, I shall solely be legally and financially responsible for all costs related to the injury, death or damage to the other dog and/or person as well as my-own dog. I AGREE TO FULLY INDEMNIFY, RELEASE AND HOLD HARMLESS VETSCIA AND ITS OWNERS, CONSULTANTS, TRAINERS, PRINCIPALS, AGENTS, REPRESENTATIVES, AND THE PROPERTY OWNER WHERE TRAINING IS HELD FROM ANY AND ALL LIABILITY AND CLAIMS OF ANY NATURE INCLUDING BUT WITHOUT LIMITATION ALL COSTS, LOSSES AND LEGAL EXPENSES INCURRED OR ANY OTHER CLAIMS, INCLUDING ORDINARY NEGLIGENCE, BROUGHT BY MYSELF OR A THIRD PARTY ARISING FROM OR RELATED TO THE ACTIONS OF ME AND/OR MY DOG(S).	
4.	I understand that all dogs participating in the Training must be free of all infectious diseases and must be current on all appropriate vaccinations, including bordetella, distemper, parvovirus and rabies. However, I understand that it is still possible for a dog to become ill, even if vaccinated. I UNDERSTAND THIS RISK AND AGREE THAT VETSCIA OR ITS OWNERS, CONSULTANTS AND TRAINERS ARE NOT LIABLE FOR ANY ILLNESS SUFFERED BY YOUR DOG(S) DURING OR AFTER TRAINING.	

- 5. I agree that VETSCIA its Owners, Consultants and Trainers reserves the right to determine if me and my dog are suitable for Training and reserves the right to refuse to accept us for Training at their discretion for any reason including but not limited to sick or injured dog(s), inappropriate behavior for the environment and incomplete vaccination records.
- 6. If a dog(s) in my care for whom I am not the owner, participates in dog training, I agree to assume all financial and legal responsibilities associated with participation in dog training and all terms and conditions in this Dog Training Waiver and Release shall apply without exception to myself and such dog(s)in my care.
- 7. I represent that I am the owner of the dog(s) and fully authorized to enter into this Dog Training Waiver and Release, have had the opportunity to discuss it to my satisfaction and agree to its terms.
