#### NOTE:

This summarized decision is being posted as the Parties have received it. Occasional requests for clarification are not posted. However, should any Stakeholder requests it, a copy of such clarification will be sent to her/him.

#### Decision:

Having understood the Applicant's plea of keeping the "old" IATA numeric code, mainly for the purpose of not risking the Lufthansa ("LH") Franchise, I approached IATA to get their input in order to see if this case could be treated as an exception. I sympathize with the Applicant's situation and find partly a misfortune, but not all, of why its Agency got the Notice of Termination.

After having re-visited all the statements done since September 2016, and especially after having learnt that, despite several reminders, the Applicant still has outstanding debts to Airlines, I cannot find reasons enough for allowing an exception.

Therefore, IATA can proceed with the termination as mandated by Resolutions.

Having said the above, I am confident that a new application for IATA accreditation will be handled as expeditious as possible by IATA and should the Applicant's LH franchise be endangered, SOLELY because of the change of IATA numeric code, if asked for, I will assist in explaining to the Franchise Provider why there was a Resolution's requirement for change the IATA numeric code.

# CLARIFICATION RENDERED ON JULY 24<sup>TH</sup>, 2017

Dear Applicant,

Your plea has been carefully read and I fully understand the consequences if the served Decision stands.

I have re-visited all the statements and documents provided by both Parties looking to find any "new" mitigating circumstance, but, unfortunately, I have not found enough new evidence to change my Decision (July 24<sup>th</sup>, 2017).

Just to reiterate, that Decision was mainly based on my believe that even if you did have a tragic accident and you were hospitalized for a long period, having an IATA accreditation entails to have being entrusted by IATA, on behalf of its Member Airlines, their financial situation in an Agent's hands.

Thus, the Decision stands.

It is imperative that management of an Agency is secured at all times and I strongly advise you to demonstrate to IATA that you do have "back up" in place when reapplying.

And once again "... should your LH franchise be endangered SOLELY because of the change of IATA numeric code, if asked for, I will assist in explaining to the Franchise Provider why there was a Resolutions requirement for change in IATA numeric code."
