#### NOTE:

Occasional requests for clarification are not posted. However, should any Stakeholder requests it, a copy of such clarification will be sent to her/him.

### Background:

In the email dated 17 January 2018 IATA asks for:

- a) Updated financials
- b) "Current photos"
- c) Most recent utility bill

and acknowledges that: "... once they are accepted we will start the process".

This request does not, as I understand IATA's statement, amount to a "New Application".

I will not recreate the full story why the application has taken this extraordinary long time, so please **accept this document as a formal TAC decision** and, after compliance from *Alkhalil Hajj Travels Ltd.* (UK), allow IATA to fully finalize the application process.

#### **Considerations and Decision:**

The initial application was sent to IATA in **January 2016**. 2 years of processing an application is an extraordinary long time, and as stated *supra*, I will not "point

fingers" to either Party, therefore, this Decision will disregard the circumstances over the reasons behind such a delay.

By that, I will also allow that documents which were relevant and valid at the time of the original application to be considered valid today, unless there is a "relatively easy access" to update such material.

## Consequently, the Decision is as follows:

- A) The Applicant has to submit a copy of the "latest audited annual financial statements" filed at Companies House. If the fiscal year coincides with the Calendar Year then *Alkhalil Hajj Travels Ltd.* (unless not already done so) has to submit the financial statements corresponding 2016;
- B) Additionally, 2017 fiscal year's audited financial statements, disregarding requirements by Companies House, have to be submitted **not later than 30<sup>th</sup> of April 2018**;
- C) The photo/photos sent in October 2017 by the Applicant have to be accepted as they are for the application;
- C) "Most recent utility bill" has to be provided by the Applicant as requested by IATA.
