### NOTE:

This summarized decision is being posted as the Parties have received it. Occasional requests for clarification are not posted. However, should any Stakeholder requests it, a copy of such clarification will be sent to her/him.

### Considerations and Decision

On January 19, 2018 IATA proposed a repayment agreement, which was not signed by *Olinet Sarl* Togo (also refer to hereinafter as "the Agent"). The repayment agreement proposed a settlement plan of six instalments with the final one being on 30 June 2018.

After several reminders a first instalment was paid on 14th of March. Obviously *Olinet Sarl* was not able to honour the repayment plan so IATA, after having informed the Agent of the consequences of not following the repayment "agreement", terminated the Agent's Passenger Sales Agency Agreement on 01 May 2018.

A letter dated 02 May, 2018 signed by Mr. Georges Amousson, General Manager of ITP and representing the "Shareholders" confirms that a shareholders meeting had decided to honour the debt in full by the original dead line of 30 June, 2018.

This Office does acknowledge IATA's need for strict routines and by that confirms that IATA has acted according to Resolutions' requirements.

Having said the above, it is this Office's view that the efforts of the Share Holders of *Olinet Sarl* Togo are laudable and since the "final payment" still is according to IATA's suggested repayment plan, it is herby decided as follows:

- *Olinet Sarl* (since 30 June is a Saturday) is allowed a new final Deadline to repay in full (interest and fees included)
- Final Deadline is 29 June, 2018.
- IATA is to re calculate the remaining interest and fees not later than 08 May, 2018.
- AFTER repayment in full and all other reinstatement requirements have been met,
- Olinet Sarl can be reinstated as Accredited Agent.

This Decision is effective as of today.
