3. Deposits: All deposits are **non-refundable** unless death or injury of said puppy/dog occurs while puppy/dog is still in the care of Cross L Aussies. Pick deposits may be transferrable to future litters until your standards outlined above are met.
 - a. Funds Accepted at NO fee: Cash, money order, Facebook Messenger, Walmart to Walmart, Apple Pay or Venmo. We will not longer be accepting PayPal in any form.
 - b. If sending a money order, it must be sent USPS Priority mail, with tracking provided to Seller before seller places puppy on hold. Seller will hold puppy for five days from the time they place deposit in the mail and tracking is provided.
 - i. In the event funds are not received in five days, the said puppy will be made available again by the seller.
 - c. Credit Cards may be accepted but there will be a 3% fee added to the total.
 - d. In the event death or injury while still in the care of Cross L Aussies, the deposit will be refunded in full.
 - e. Pick Deposits: If deposits are placed prior to puppies being born for a pick puppy, picks must be chosen by 3 weeks of age.
 - i. We will start allowing selections in order once all eyes are open and once testing results are back if there is any testing being done of the pups.
 - f. If you pay a pick puppy deposit prior to the litter being born or the eyes opening and the color or eye color you want is not produced, the deposit will not be refunded. The deposit will be retained for pick of future litters.
 - g. Pick deposits will not be transferrable to different sex/and or color of pup.
 - h. If the estimated height at maturity of the puppy changes prior to full payment of puppy and the buyer decides the said puppy is no longer what you want, there will not be a deposit refund.
 - i. It may be transferrable to future puppy if decision is made prior to the said puppy reaching 5 weeks of age.
 1. Future puppy must be the same color and sex as the original deposit.
