#### **Active Voting**

- The Chief Law Enforcement Officer of a Township, Village or City of the State of MI
- Any MI County Sheriff
- Any MI State Police-District, Post, or Section Commander
- Police Chief or Director of Public Safety of any duly organized police dept, of a learning Institution in the State of Michigan

#### **Active Non-Voting**

- The Director of a County Central Dispatch
- The Laboratory Director of a Regional State Police Forensic Science Lab
- The Resident Agent in Charge of FBI, DEA, ATF or USSS
- A County Prosecutor
- A Director of Emergency Management
- The District Officer of the DNR
- The MI representative for Federal Govt. Regional Intelligence Sharing System (RISS) Example: MAGLOCLEN
- The Director of any recognized Law Enforcement training facility / program within our Region
- The Coordinator of the Law Enforcement Action Forum (LEAF) from the MI Municipal League (MML) or the equivalent from any liability carrier.
- Voting Members with departments of 30 or more sworn full-time officers can name one person whom hold the designated rank just below the Chief/Sheriff.
- The Assistant Post Commander of any State Police Post within our region.
