## SALES RECEIPT (ADULT & WEANED KID)

5) Buyer understood that **SnR's Farm would be doing all registrations & transfers at buyer's expense as it is the buyer's responsibility to pay for all fees regarding the registration and transfer of said goats and the postage fee to mail said registration papers to buyer once transferred into buyer's name.** Once registration papers are received, SnR's Farm will mail said registration papers to the buyer at the buyer's expense of a postage fee of either \$3.00 for regular mail or \$10.00 for certified mail. Buyer has agreed to have registration papers mailed to them via \_\_\_\_\_ mail and will not hold SnR's Farm responsible for lost mail. Buyer understood they must pay the registration, transfer & postage fees in cash at time of pick up along with any out standing purchase fees to SnR's Farm. **Buyer understands that if purchasing a wether that said wether will not be registered.**

6) Buyer understood that if the goats were not picked up by 5 pm on day 14 or on the 1st date agreed on, a boarding fee of \$5.00 per day, per goat, would be applied at that time and that all fees must be paid in full prior to goat leaving SnR's Farm. Buyer agreed to the pickup date of \_\_\_\_\_.

7) Since SnR's Farm cannot possibly, have any control over how a goat is managed once leaving SnR's Farms possession, it will be understood that upon the goat leaving SnR's Farm, all liabilities and responsibilities for the goat immediately transfers to the buyer. SnR's Farm will not take a goat back, due to the fact that the goat might have been exposed to diseases while away from SnR's Farm.

8) As the goat represents a potential, SnR's Farm cannot/will not guarantee that the purchaser will like their goat once they get it home. SnR's Farm cannot/will not guarantee how large a goat will be. SnR's Farm cannot/will not guarantee how much milk a goat will produce. SnR's Farm cannot/will not guarantee that a goat won't grow scurs (small horn growths). SnR's Farm cannot/will not guarantee the future health of the goat. SnR's Farm cannot/will not guarantee the goat will be of show quality, breeding quality, or fertile. If goat is sold bred, it is understood by both parties (buyer and SnR's Farm) that said goat is "merely presumed with kid" and is not guaranteed with kid. There will be no refunds for any reasons.

9) **A goat is not bought until it is paid in full AND LEAVES SNR'S FARM. No personal or business checks will be accepted at any time.** SnR's Farm reserve the right to accept cash only at time of pick-up.
