- All cancellations must be made in writing and be dated and received by the gen·e·sis **yoga** Director of Teacher Training, Pam Milner.
- If cancellation occurs up to one-month prior to the start date of the training, the student will receive a full refund, minus the \$500 deposit.
- If cancellation occurs less than one-month prior to start of the training, the student will receive a refund of 50% of the tuition price.
- If cancellation occurs less than 2 weeks prior to training start date, the student will receive 25% of tuition price.
