

## **Consignment Agreement**

## Terms and conditions

- 1. Seller (Triple Force) reserves the right to refuse any business offer.
- 2. Free consultation
- 3. Seller will use discretion with each listing and will attempt to sell each item for the highest amount possible.
- 4. Price Reductions: All consignments may be subject to price reduction at the discretion of owner and seller.
- 5. 10 Items will be listed within one week (5 business days) of contract signing. No more than 50 Items will be running for sale at one time. No matter how many items you send with us, we will only guarantee 50 running listings at any given time.
- 6. **Profits**: Consigner (you) receives 50% of the final selling amount less 6% sales tax and Seller(us) keeps 50%. Seller (us) will pay all other fees from the 50% kept. This includes eBay, PayPal, Shipping and any other related fees.
- 7. Seller promises to keep Consigner informed monthly via with a sales progress reports.
- 8. At the end of each calendar month the Consigner is paid and a detailed receipt of all transactions is provided.
- 9. *Liability*: Triple Force assumes no responsibility for the loss or destruction of any item but promises to care for the inventory with the highest regard. Items will be stored in a locked location.
- 10. If the merchandise doesn't sell within 30 days then the items are returned or the agreement renewed. This will be determined by both Consigner and Seller.
- 11. *Renewability*: This Consignment Agreement is renewable three times. The total consignment length may be a maximum of three months.
- 12. The Seller will not reveal the Consigner as the source of inventory unless A) the Consigner has authorized this with a written notice, or B) the Seller has this information demanded by the authorities through a court order.
- 14. Seller (Triple Force) will not sell pornography.
- 15. Seller will not send out checks for less than \$5.00 All sales will be held until that amount has been met.
