

5. Membership Officer

LM advised that due to the new terms of reference, **LM proposes** that Paul Murray become a coopted partnership member, **DP seconded, vote carried by all members.** LT welcomed PM to the partnership. No other members currently able to join.

6. Public Consultation/New Plan

Lt explained about the consultation work we have been doing and that Kim Donoghue (KD) had been doing this work and we now have a draft plan, comments were welcomed and would be taken back to KD. We are still doing consultation work within the local community and this will continue until Local Trust is happy with our plan. JB showed a presentation of the initial results from the consultation work that KD has done. And the breakdown of support for different projects that has already started or is proposed and if the community is in support, against or neutral. There were 109 responses.



This will be discussed in more detail at the meeting on 9th July and all local residents are welcome to attend. DM asked about the Bus Turning Circle, LT advised that he could organise a meeting with Kent County Council Local Councillor for residents to discuss in more detail. DM also asked who would be financing it, LT advised that we would fund some of the project which may include purchase of the land and JB advised that we would possibly also look at a partnership on the purchase. JB stated that fees for planning permission, architects and designers we would look at a Community Land Trust and contact a partner, possibly a housing association to help with the buildings on the site. SI advised that they had done their own survey with local residents that had been forwarded on to LT regarding the proposed Dog Walking Park. LT advised that this has been sent to KD to take into account with the consultation. LT advised that the proposed Dog Walking Park will possibly not go ahead in its current form, the CIO that has been set up covers so much more than just a dog walking park. SI advised that our consultation work is only from 109 people and that the survey they had completed had 93 residents in Sea View Avenue against the proposed dog walking park and do not want this project to go ahead. GW advised that there is already dog walking areas within the coastal park and the residents in Sea View Avenue do not want a fenced in area that would be costly to maintain. KB stated that he has two issues, we say that BLES wants to create a legacy but we would be wasting the money in fencing that would be vandalised and how much would the insurance cost be. CC also stated that the vegetation is very long and that there is plenty of wildlife that lives within the area so the cost to clear it would be very costly. LT proposed that we do not take the dog walking park in its present shape and form any further on this consultation and is removed from the new plan, MP seconded. IG proposed that partnership members and local residents visit Brightswood in Eastchurch that has been turned into a conservation area to include dog walking. DH stated that's it's a good idea but its where to put it as obviously the immediate residents in the proposed area do not want it, so is there another area in Eastern Sheppey that can be looked at. HM states that he doesn't think it is a good idea, Leysdown is a coastal park and a natural habitat and dog walking parks are more for built up areas where space is sparse. All partnership members voted for LT proposal and is removed from the new plan.

7. Community Chest Ratification

SH advised members that one of the applications was received after the deadline and the members agreed to accept it. IG & LM declared and interest in 5th Sheppey Scout Group and left the meeting for the duration of this discussion. SM declared an interest in Sheppey Matters application.
